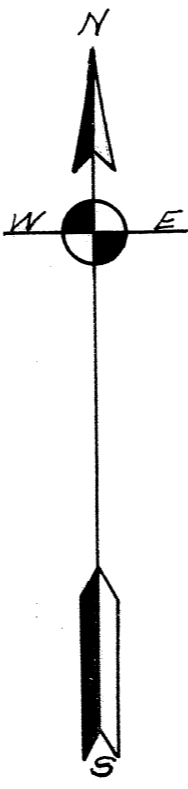
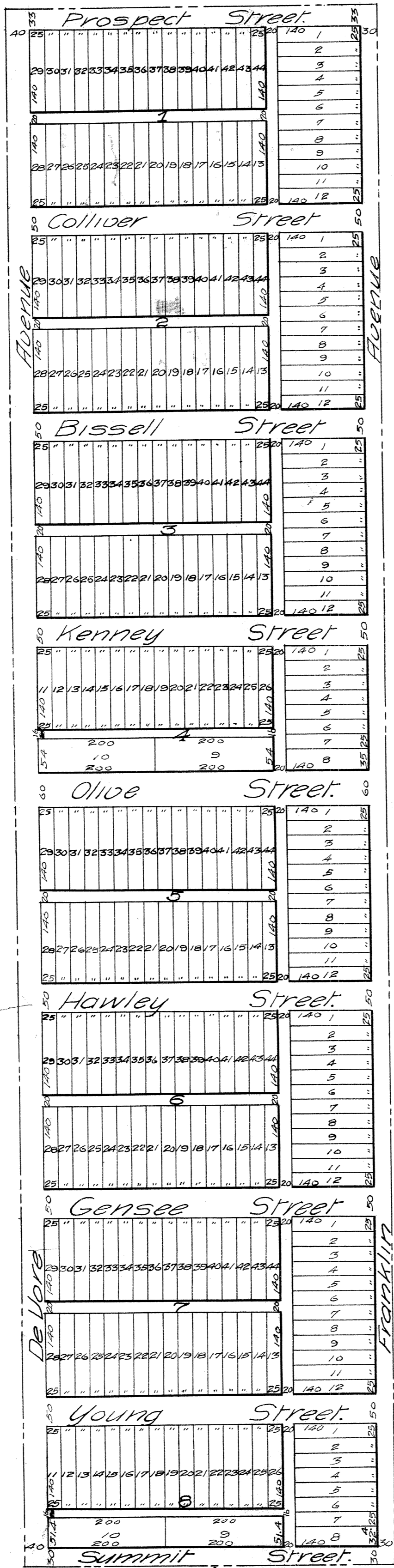
A Subdivision of Part of Blocks 9 and 10 Volz Addition
