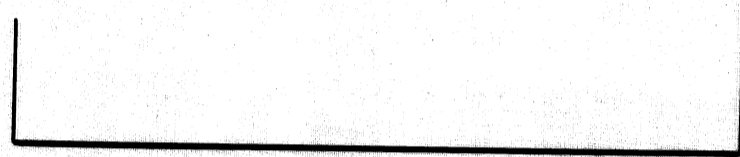

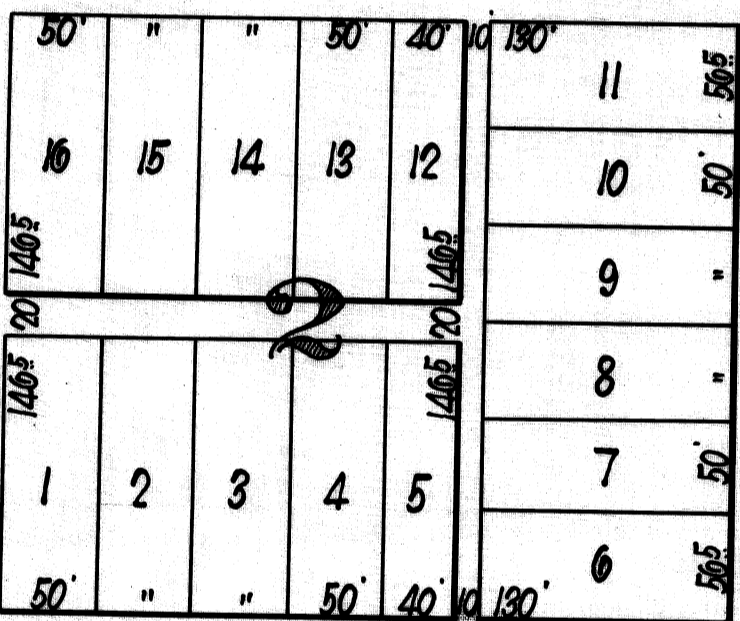

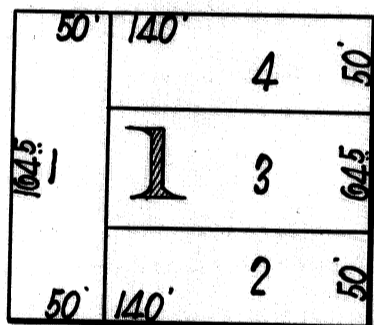
60' TWENTY-SIXTH ST. 60'
