I, Charles Chamberlin, a resident of Oklahoma County, Oklahoma Territory do hereby certify that by occupation I am a civil engineer and surveyor. That at the instance of Anton H. Classen I surveyed into Lots, Blocks, Streets, Avenues and Alleys, the following described land, commencing at the intersection of the West line of Normal Street and the North line of Main Street as laid out in the City of Edmond running thence Northerly and along the West line of said Normal Street 140 feet, thence Westerly and parallel to the North line of Main Street 857.5 feet, and to the East line of the Boulevard so called, thence Southerly and along the said East line 400 feet thence Easterly and parallel to said Main Street 857.5 feet, thence Northerly and along the West line of said Normal Street 260 feet to the place of beginning. That the land surveyed and platted aforesaid is described as follows: Commencing at the intersection of the West line of Normal Street as laid out and the North line of Main Street as laid out in the City of Edmond, running thence Northerly and along the West line of said Normal Street 140 feet thence Westerly and parallel to the North line of Main Street 857.5 feet, and to the East line of the Boulevard so called thence Southerly and along the said East line 400 feet. Thence Easterly and parallel to said Main Street 857.5 feet, thence Northerly and along the West line of said Normal Street 260 feet to the place of beginning.
