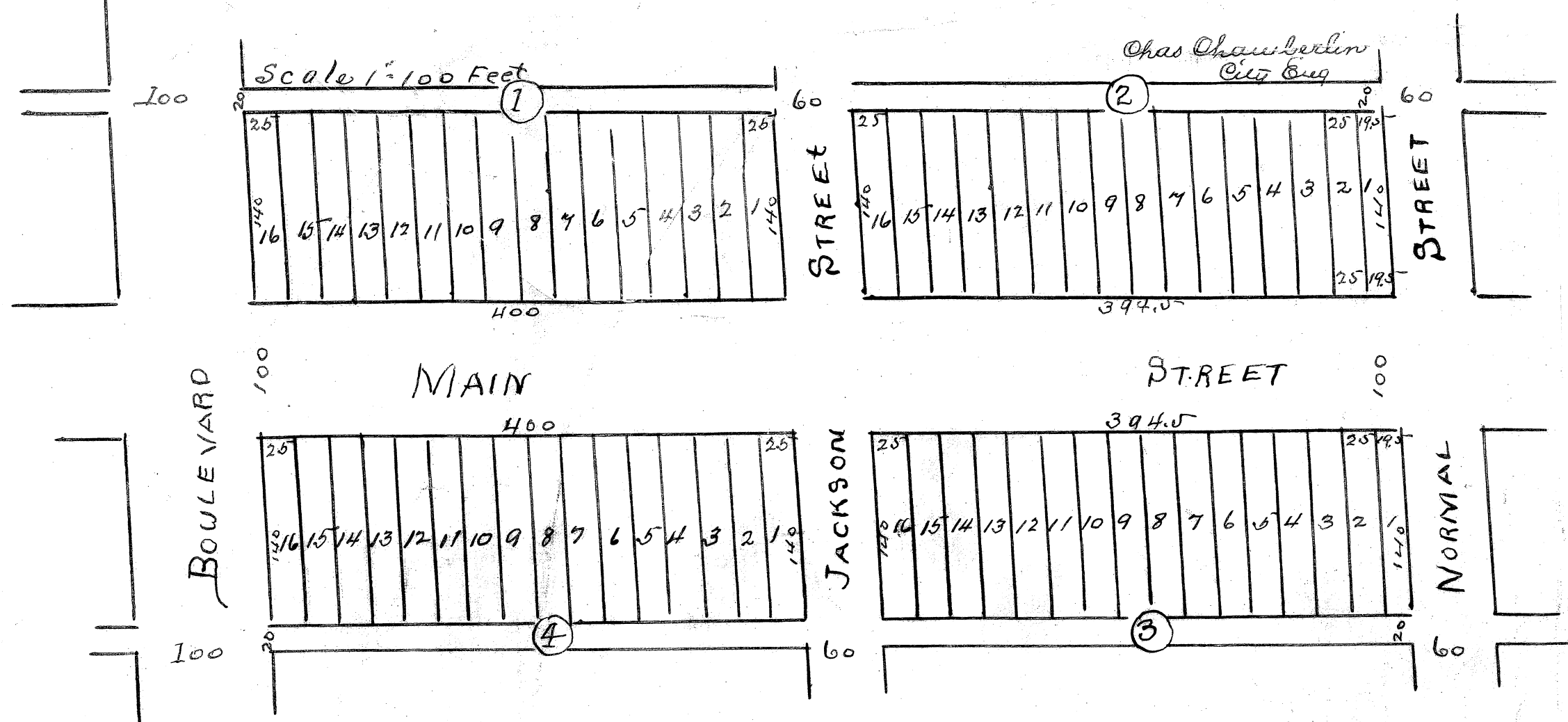

This instrument witnesses that I, Anton H. Classens of Oklahoma City, Oklahoma County, Oklahoma Territory, the owner of the land herein after described, have caused the same to be surveyed into lots, blocks, streets, avenues and alleys for townsite purposes and I hereby designate and name the same as Anton H. Classens Sub Addition to the City of Edmond, Oklahoma Co., Oklahoma Ter. That I have caused to be made a correct plat of same land as surveyed and I hereby dedicate the streets and alleys as surveyed to public use. That the land surveyed and platted aforesaid is described as follows: commencing at the intersection of the West line of Normal Street as laid out and the North line of Main St. as laid out in the City of Edmond running thence Northwesterly and along the West line of said Normal Street 140 feet, thence Westerly and parallel to North line of Main Street 854.5 feet and to the East line of the Boulevard so called, thence Southerly and along East line 400 feet, thence Easterly and parallel to said Main Street 854.5 feet thence Northerly and along the West line of said Normal Street 260 ft to the place of beginning. Being part of the South West quarter of section 25 township 14 North Range 2 West
