



This instrument witnesseth, that I, A. H. Classen, of Oklahoma City, Oklahoma, the owner of the land hereinafter described, have caused the same to be surveyed into blocks, lots, streets and alleys for townsite purposes, and I hereby designate and name the same Anton H Classens Seventh Addition to the City of Edmond; That I have caused to be made a correct plat of said land as surveyed; That the land surveyed and platted aforesaid is described and bounded as follows, to wit: Commencing at the intersection of the south line of Main St. and the east line of Normal St. 638.4 ft.; thence eastward along the east line of said Normal St. 431.5 ft.; thence northward parallel to the north line of Sec 36, 431.5 ft.; thence northward parallel to Normal St. 577 ft. thence westward to place of beginning.
