The undersigned does further certify that he is the only person, corporation, company, trust or association who has any right, title or interest in or to said lands so platted except for those lots heretofore sold, and that the drives and walks shown on the annexed plat are hereby dedicated to owners of each burial lot and their successors in title, for the ingress and egress to such memorial sites and it is not intended that there be any public dedication for streets, roads, or other purposes except that there be dedicated 50' for public road purposes along NE 36th and N. Midwest Blvd. and that title to said property is clear. Restrictions covering said cemetery will be filed separately.

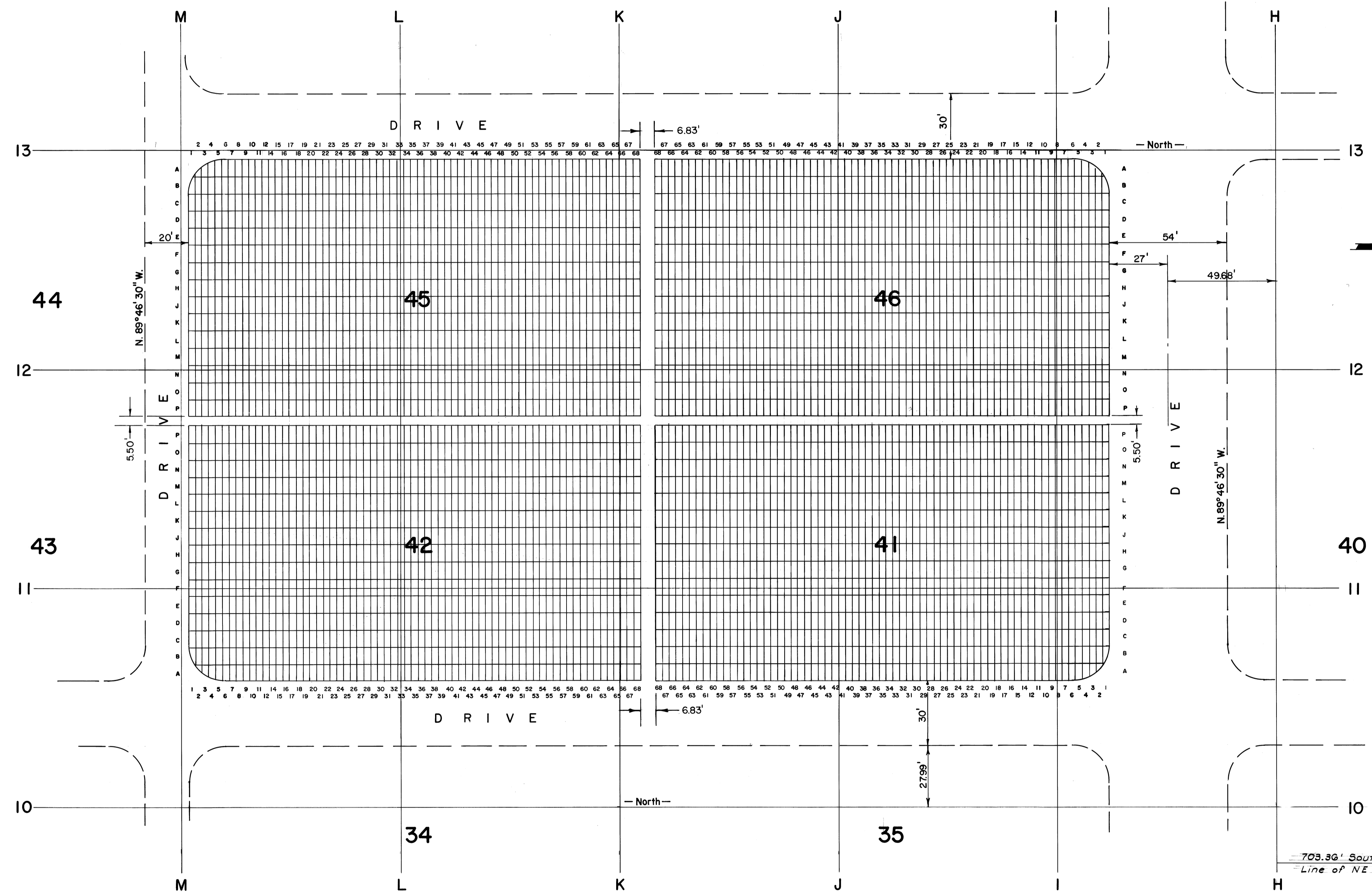

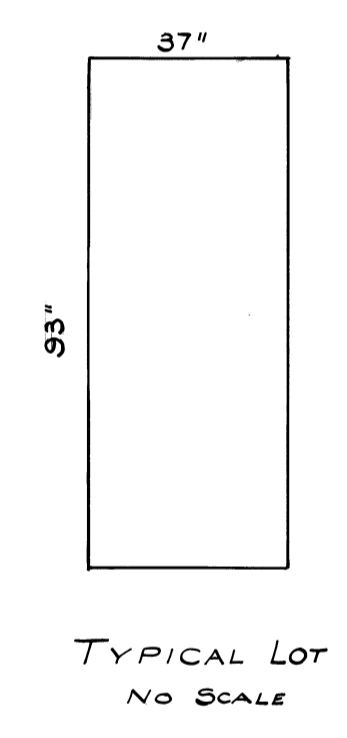
