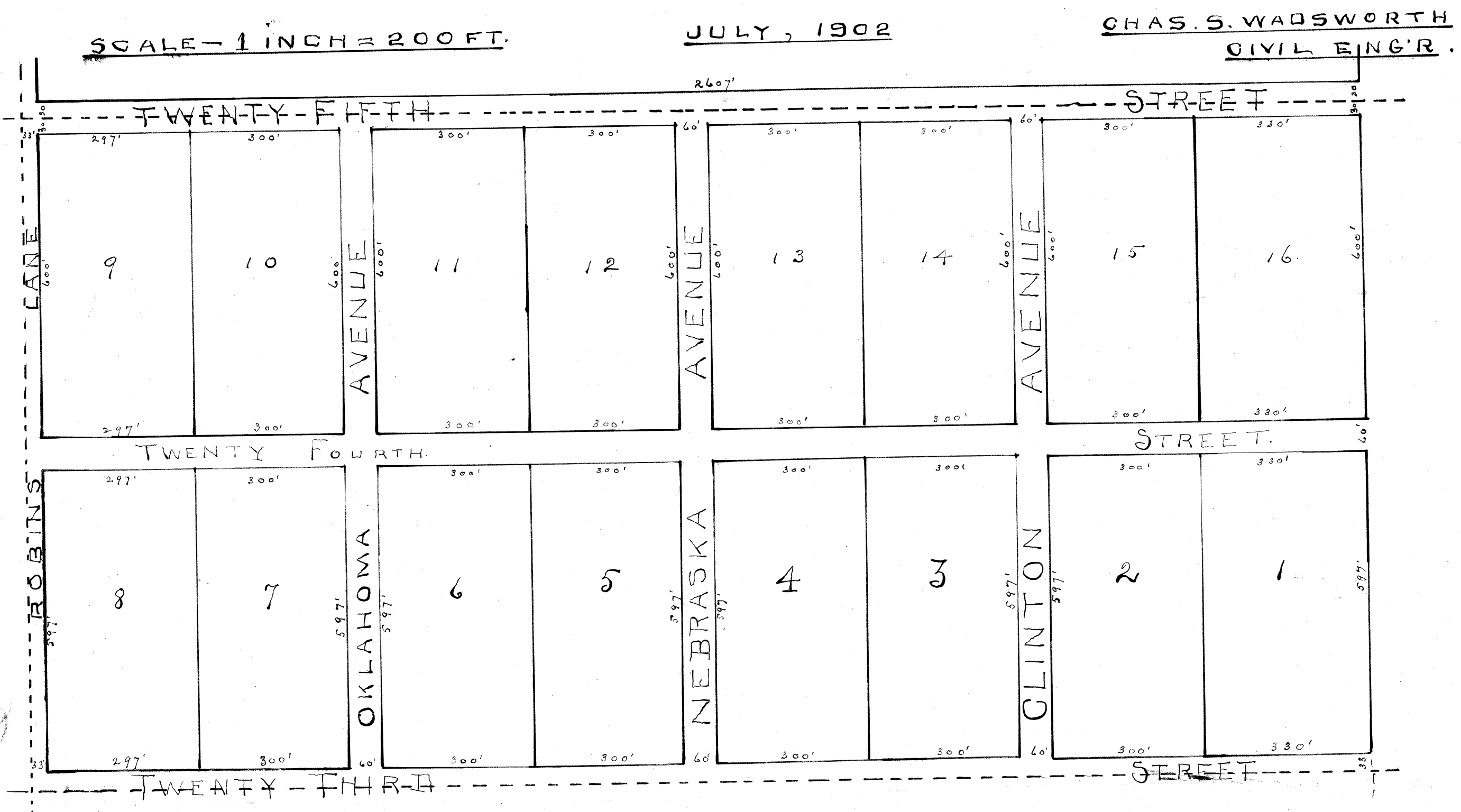


**PLAT

owners of the land herein after described, have  
caused the same to be surveyed into blocks, streets and avenues,  
and we hereby designate and name the same Barrows Addition to  
Oklahoma City, Oklahoma Territory. That we have caused the same to be  
platted and caused a correct plat of the same to be made as  
surveyed. It being the South half of the South West Quarter of  
Section 22, Town 12 N. R. 3 W. T. 1 N. and we hereby designate the  
same as Blocks No's 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15 and 16  
of Barrows Addition to Oklahoma City, O.T. and we hereby dedicate  
the streets and avenues to public use.
