

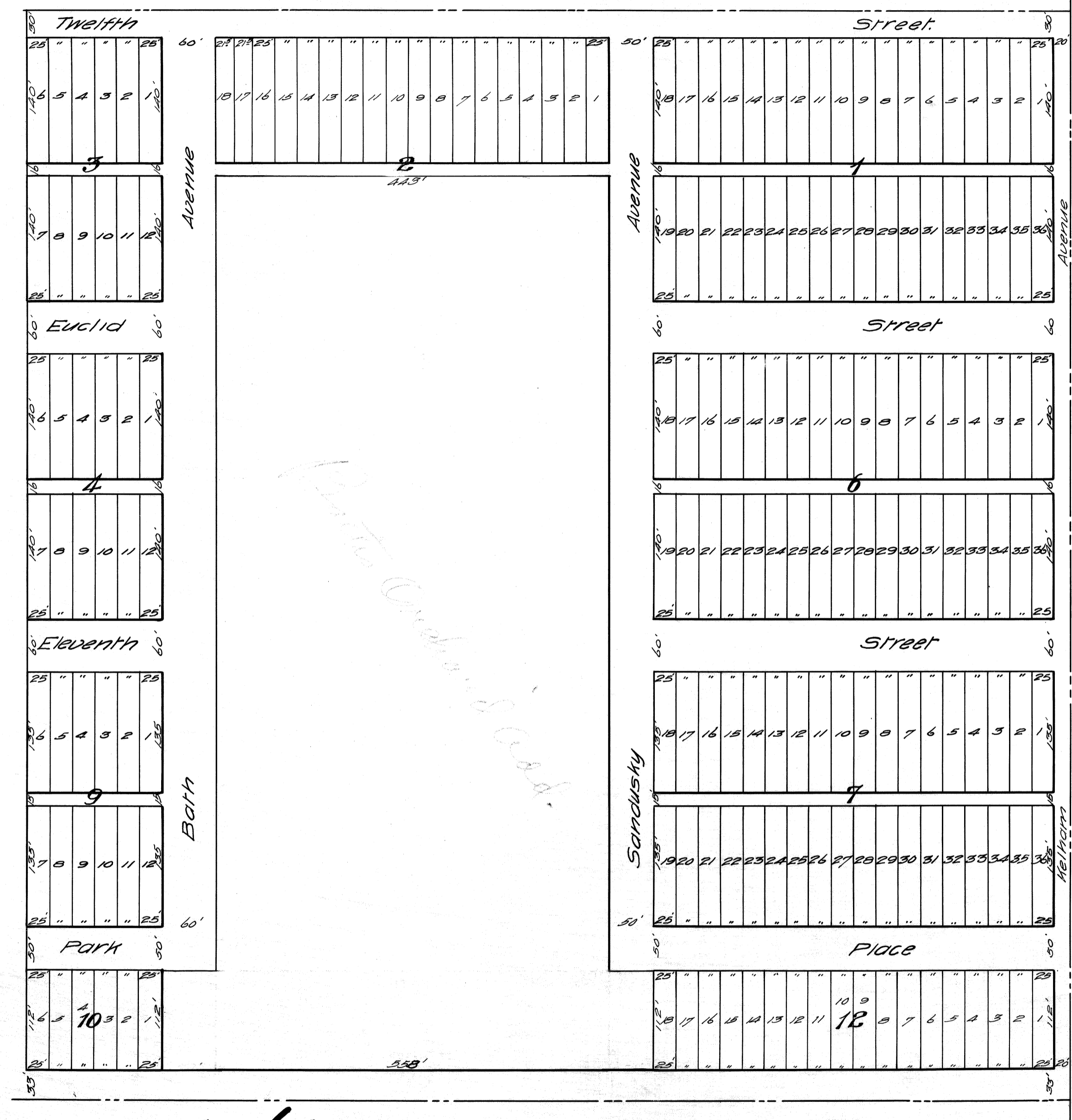
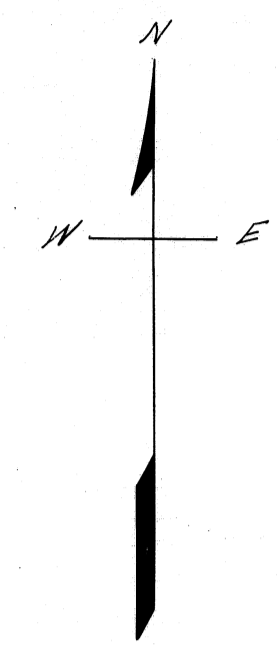

KNOW ALL MEN BY THESE PRESENTS, That we, Vincent L. Bath, and Sarah K. Bath, husband and wife, owners, have caused to be surveyed into lots, blocks, streets and alleys, the following described land in Oklahoma County, Oklahoma, to-wit:

Beginning at the Southwest corner of the Southeast quarter of Section Twenty-six (26) Township Twelve (12), North of Range Three (3) West; running thence north along said Quarter Section 1222 feet; thence east 1173 feet; thence ^{South} parallel with the west line of said Quarter Section ~~1222 feet~~ thence west to the place of beginning, - except a strip described as follows:
