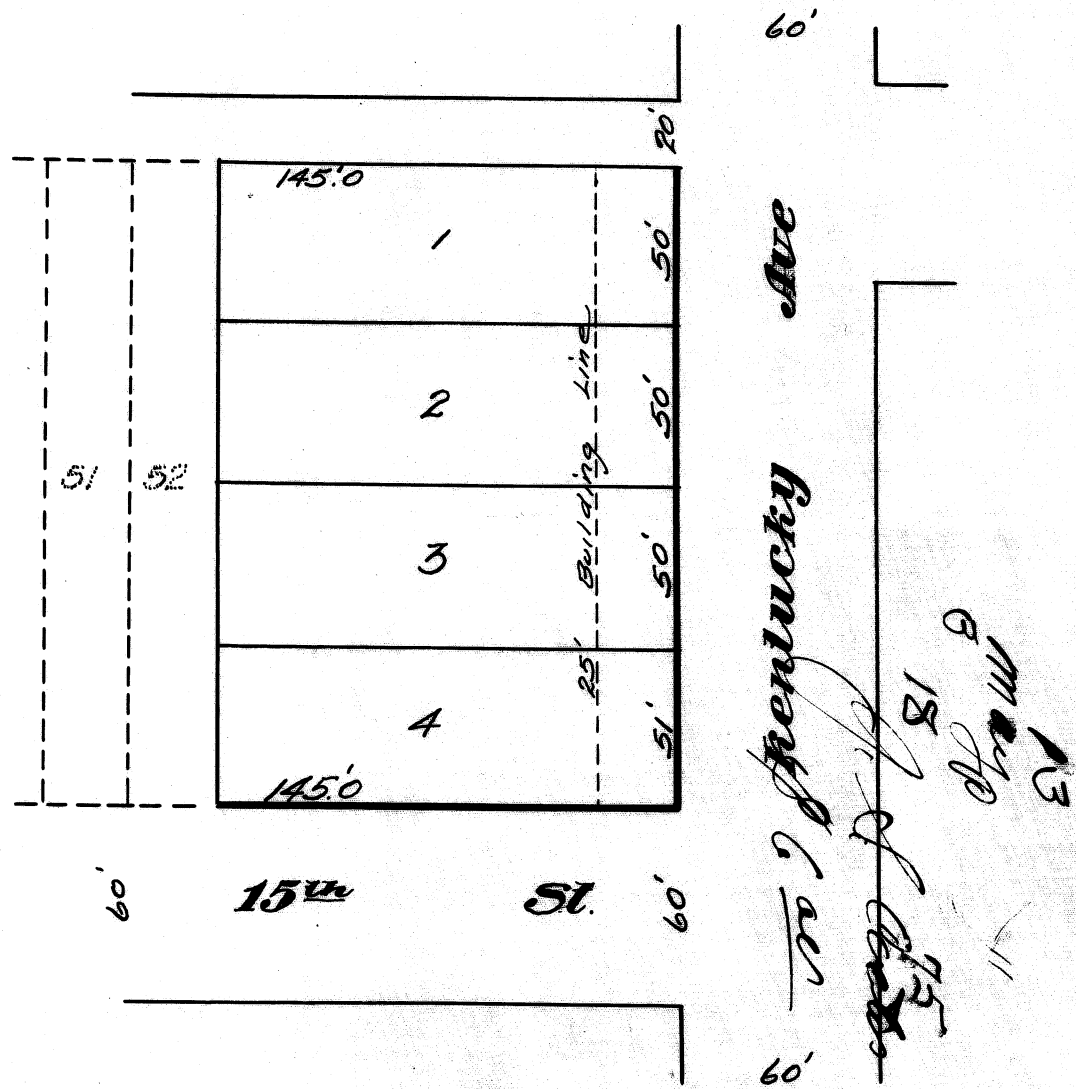

KNOW ALL MEN BY THESE PRESENTS that I, Margaret Campbell, being the owner of Lots 53 to 58 inclusive, Block One (1), Baumann's Addition to Oklahoma City, Oklahoma, have caused the above mentioned lots to be subdivided into lots numbering one (1) to (4) inclusive, as shown on the annexed plat, and that a correct map or plat of said subdivision is set on the annexed plat.

The building line shall be twenty five feet from and parallel to the front line of the property, and no building or portion thereof shall extend into the space between said building line and the front line of the property except that the front steps or porch may extend into said space not to exceed eight feet.

No lot or lots in this subdivision shall ever be held, owned or occupied by any person of African descent commonly known as a negro.
