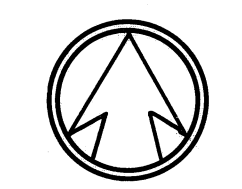


AMENDED PLAT

The restrictive covenants will be filed separately.

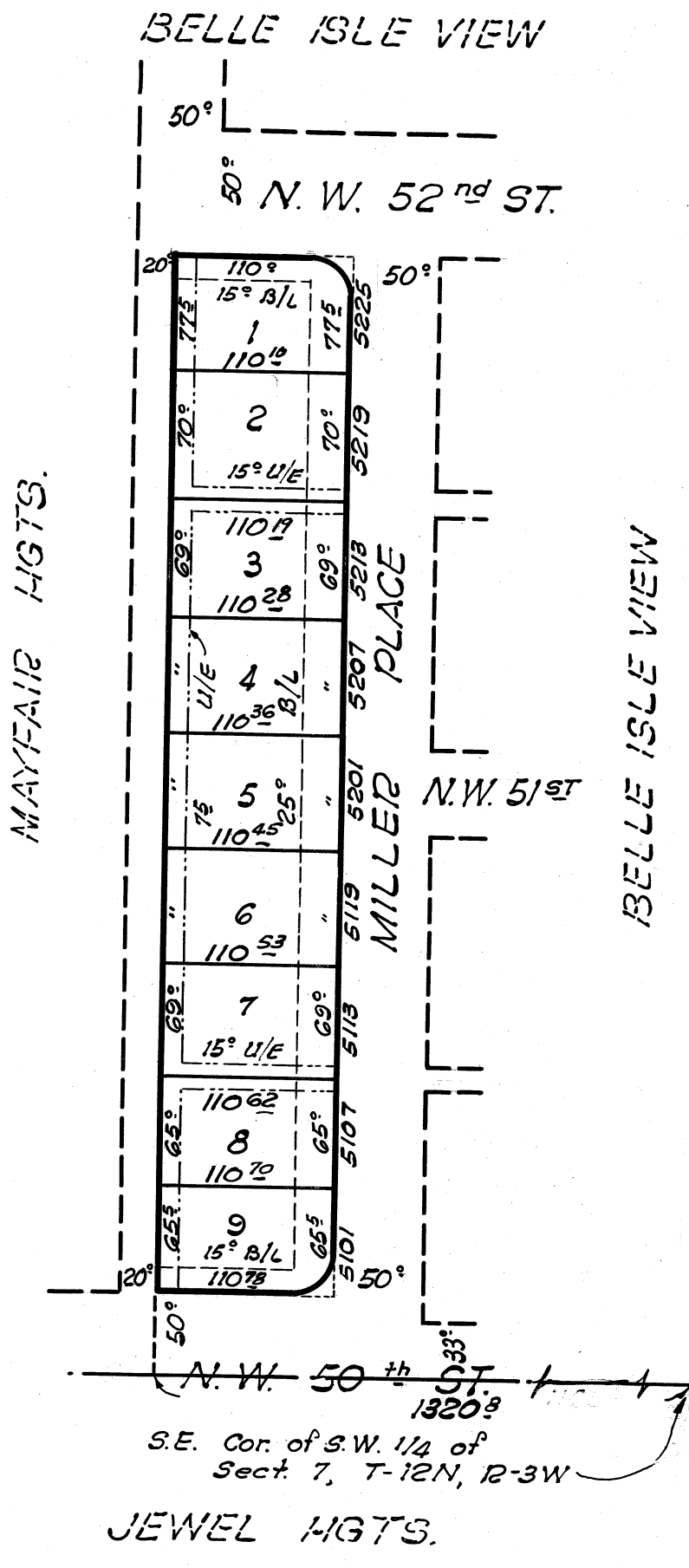

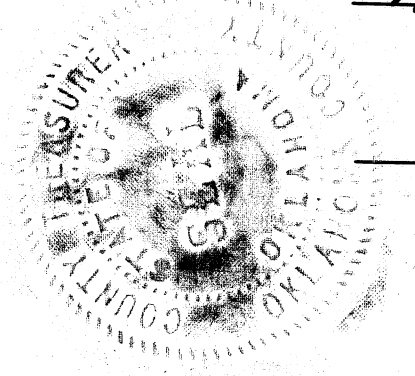
