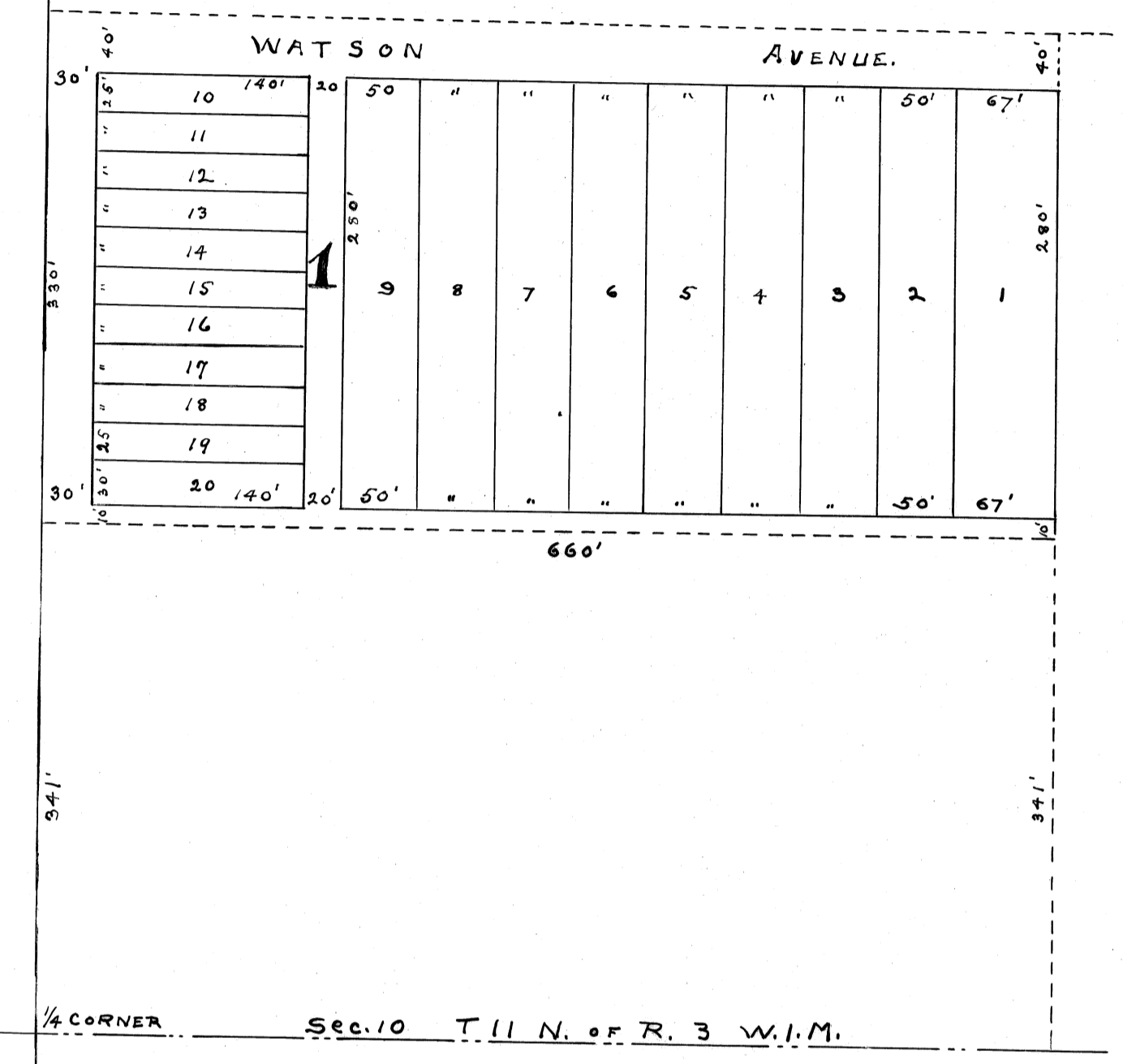


BLEVINS ADDITION TO OKLAHOMA CITY, O.T.

This Instrument witnesseth, that Mr. W. M. Blevins and Millie Blevins his wife and Thos M. Granger all of Oklahoma County, Oklahoma Territory, the lawful owners of the land herein after described have caused the same to be surveyed into Lots, Blocks, Street and Alleys the same to be known as Blevins Addition, to Oklahoma City, O. T. described as follows. Beginning at a point 341 ft North of the S. W. corner of NW 1/4 Sec 10 T. 11 N of R. 3 W. S. M. Thence East 660 ft Thence North 330 ft. Thence West 660 ft to Sec line. Thence South 330 ft on said Sec line to the point of beginning, a true and correct plat of said land in Addition is hereto attached.
