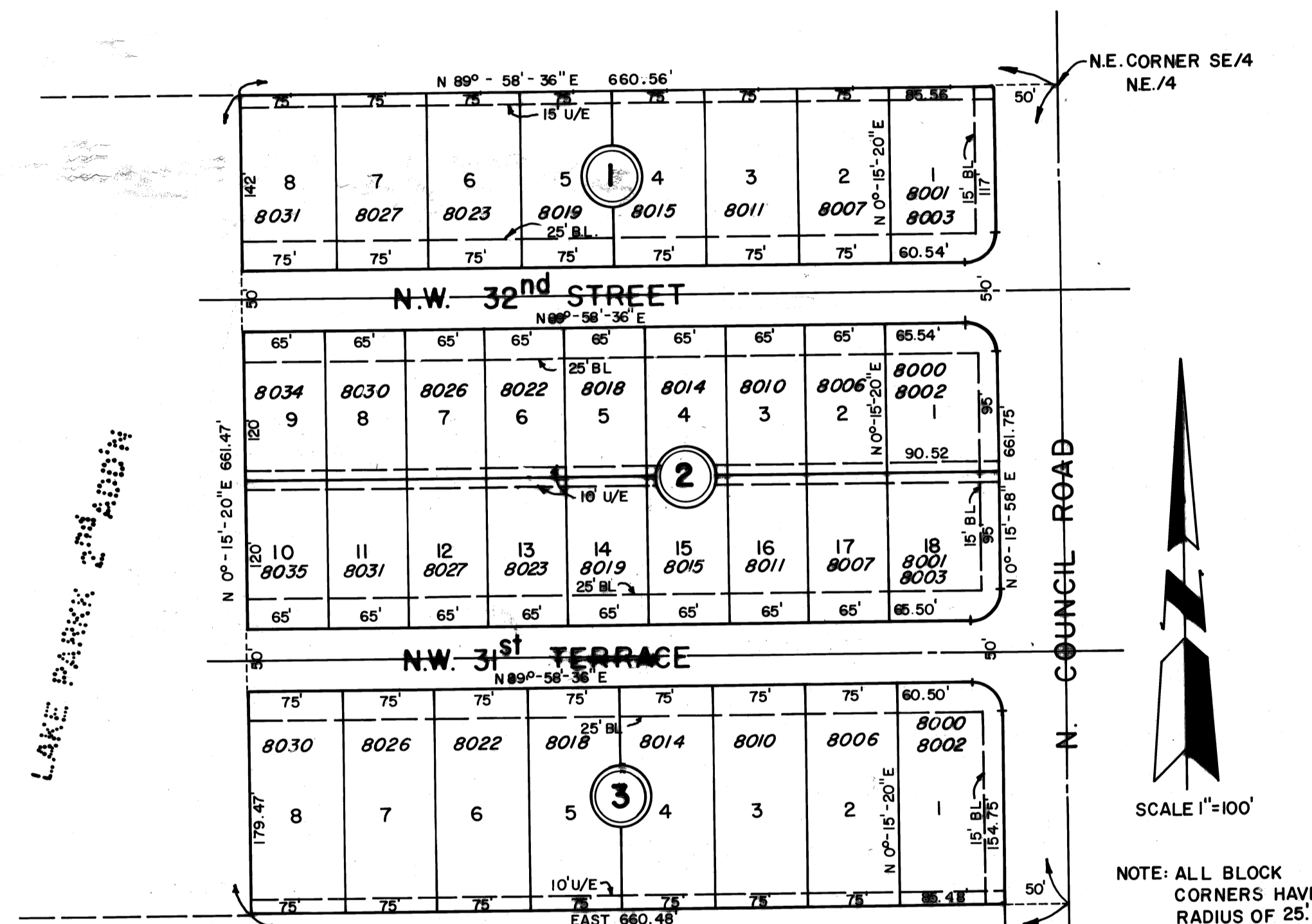

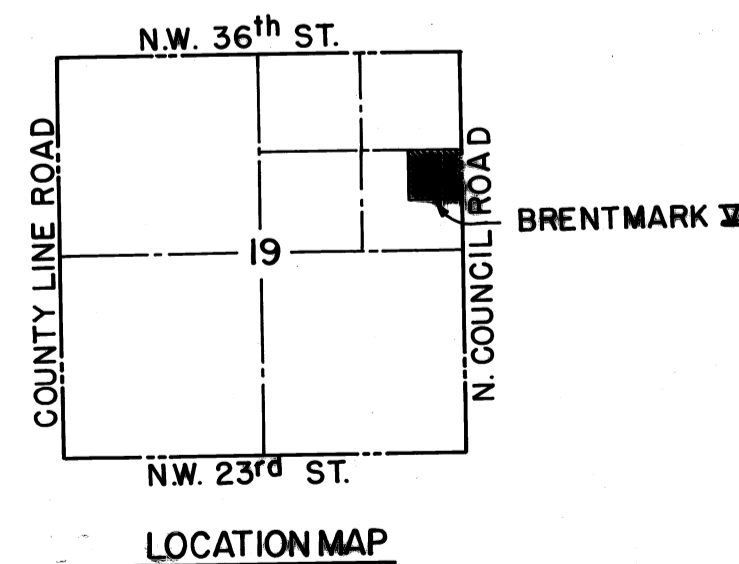
SIMPSON
