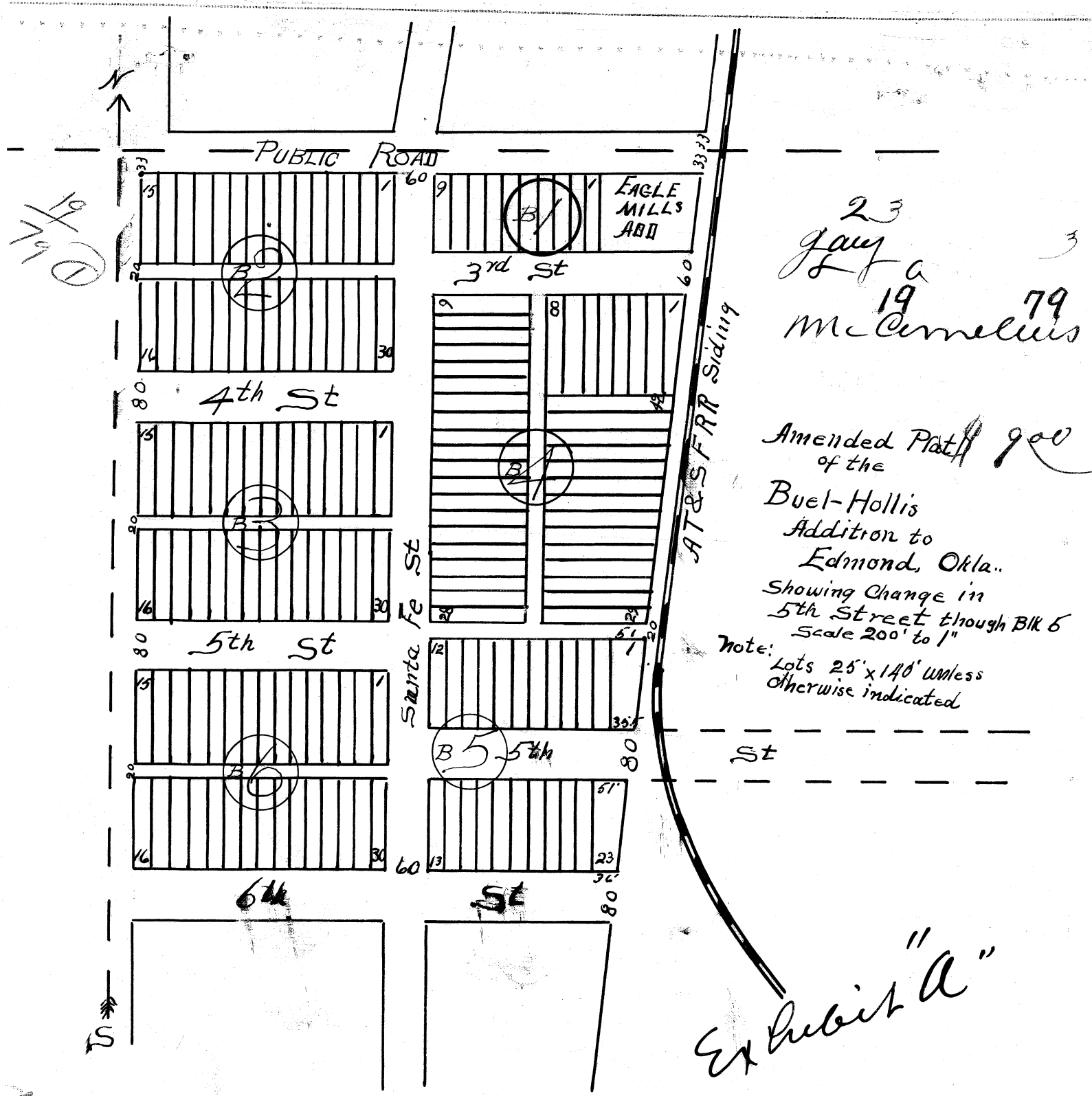

RESOLUTION. No. 31

Resolution Vacating a Portion of Fifth Street in the City of Edmond, Oklahoma.

Be It Resolved by the Mayor and Council of the City of Edmond, Oklahoma:

It appears that it will be for the best interest of the public in general and the inhabitants of the City of Edmond and more particularly the citizens who live in the vicinity of Fifth Street immediately West of Santa Fe right-of-way, that a portion of said Fifth Street be vacated; and

It appearing that all the property affected by such change is owned by Frank E. Buell and that he has asked for such change to be made.

Therefore, Be It Resolved, That the portion of Fifth Street in the City of Edmond, Oklahoma, lying and being immediately West of the Santa Fe right-of-way and immediately North of what is now Block Five in Buell-Hollis Addition to said City of Edmond, as far West as the East side of Santa Fe Avenue, be and the same is hereby vacated, provided twenty feet on the North side of said Fifth Street shall be and the same is left for alley purposes, such alley to be twenty feet wide and along the North side of the portion of said street being vacated, the part herein vacated being sixty feet wide and the alley left being twenty feet wide, as aforesaid. This conditioned that a street shall be opened up on what is now the alley thru said block Five, such new street to be eighty feet wide and the present alley to be used as a part of such new street, said new street to be an extension of Fifth Street aforesaid.
