BUELL-HOLLIS ADDITION TO EDMOND, OKLA.

This instrument witnesseth that F. E. Buell and Thos. Hollis (Thos. Hollis & Fannie Hollis his wife and Abbie Buell (widow of Edmond T. Buell)) of Edmond, Oklahoma, owners of the land hereinafter described, have caused the same to be surveyed into blocks, lots, streets and alleys for domestic purposes, and hereby designate as and name the same BUELL-HOLLIS ADDITION TO THE CITY OF EDMOND; that we have caused to be made a correct plat of said land as surveyed; that the land surveyed and platted aforesaid is described and bounded as follows: Being a part of the northeast 1/4 of sec. 35, in Township 18 N., Range 3 W., beginning at the northwest cor. of said 1/4 sec. and running thence south 1093 feet, thence easterly, thence north-easterly along said railroad right-of-way 913 ft.; thence north-westerly at right angles to said right-of-way 126 ft.; thence north-easterly, parallel to said right-of-way 173.87 ft. to north line of said 1/4 sec.; thence westward along this line to place of beginning. And hereby dedicate the streets, avenues and alleys, as surveyed, for public use.

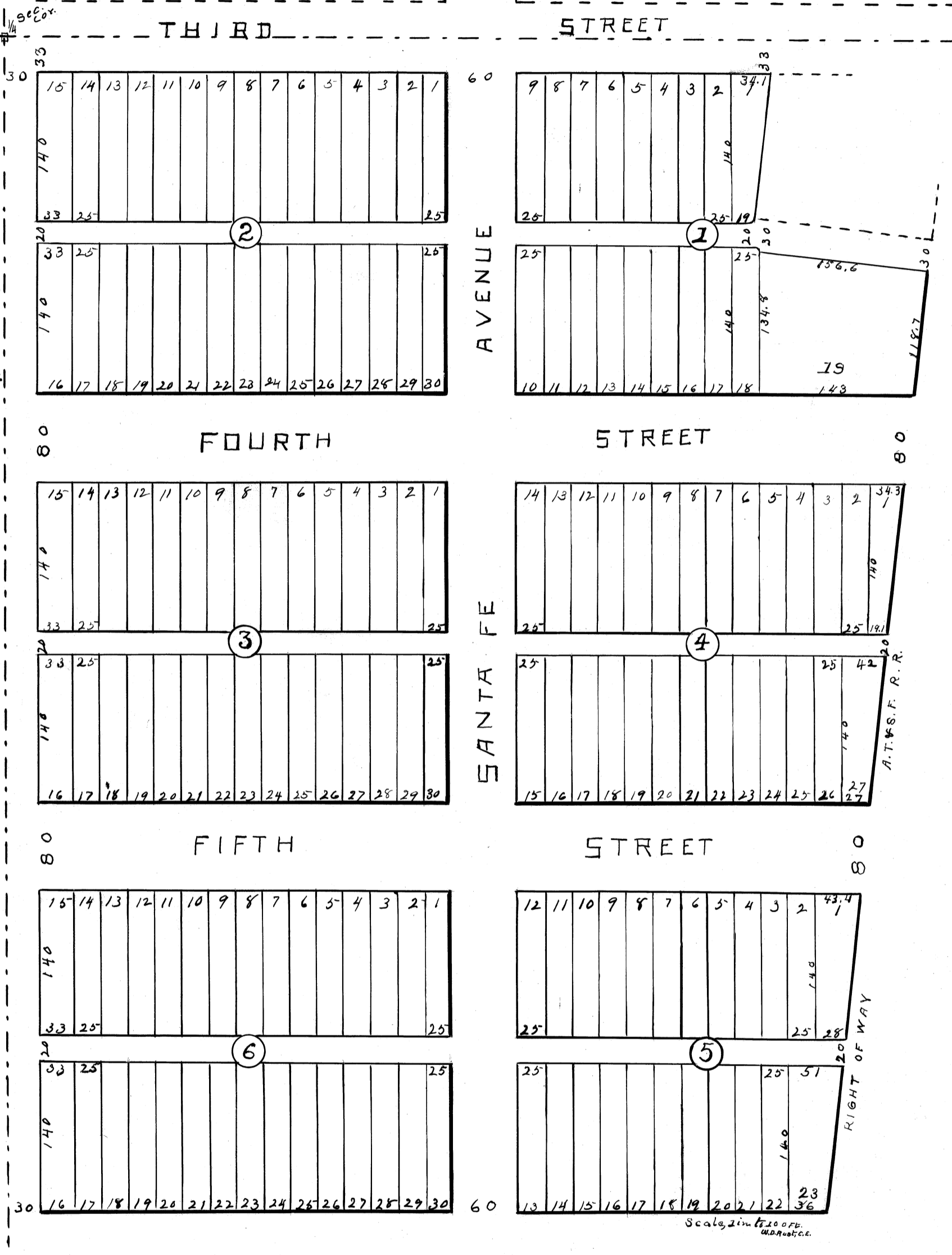
