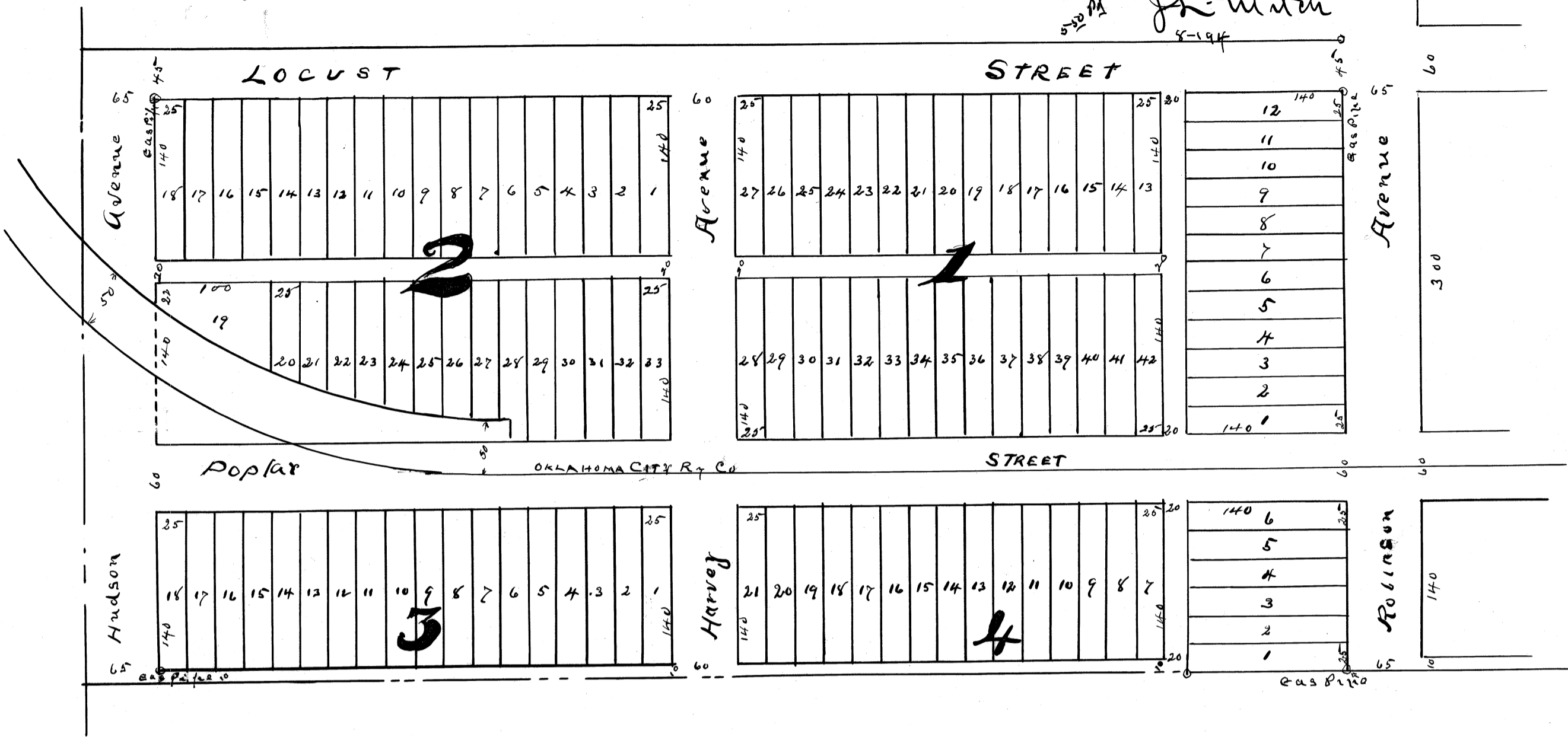


REVISED PLAT

Know All Men By These Presents:
That the undersigned, W.R. Caldwell and Mary A. Caldwell, his wife, being the absolute owners in fee simple of all the property herein mentioned and being the sole owners of the real estate described in a certain plat filed on the 14th day of July, 1905 in the office of the Register of Deeds of the county of Oklahoma and Territory of Oklahoma, duly recorded in Plat Book 5 at page 35 in the records of said office, and designated as Caldwell's Third Addition to Oklahoma City and having sold or disposed of no part or parcel of any of the lots, tracts or sub-divisions of the said Caldwell's Third Addition to Oklahoma City, do hereby, by this deed and certificate cancel and annul the said plat of Caldwell's Third Addition to Oklahoma City, and do further certify that we have caused the annexed plat entitled Revised Plat of Caldwell's Third Addition to Oklahoma City to be made and have caused said Addition to be surveyed in accordance therewith, as follows:
Commencing on the south line of the North East Quarter of Section 9, Township 11, North, Range 3 West, at the west line of Robinson Street, thence North along the west line of Robinson Street 550 feet, thence west parallel with the south line of said Quarter Section 1100 feet; thence south to the south line of said Quarter Section; thence east to the place or point of beginning, and have caused the same to be surveyed into Lots, Blocks, Streets and Alley in accordance with the annexed plat and do hereby make and file same as the Revised Plat of Caldwell's Third Addition to Oklahoma City, vacating and annulling all previous plats; and we do hereby dedicate all the streets, alleys and public places to the public as shown on said plat. The dedication of said Poplar Street to the uses of the public, being also subject to the use of the Oklahoma City Railway in accordance with the deed of the grantors to said Oklahoma City Railway Company
