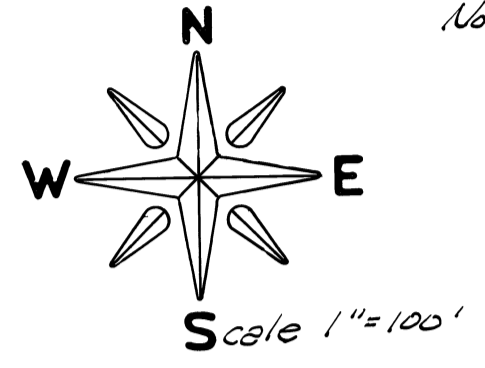
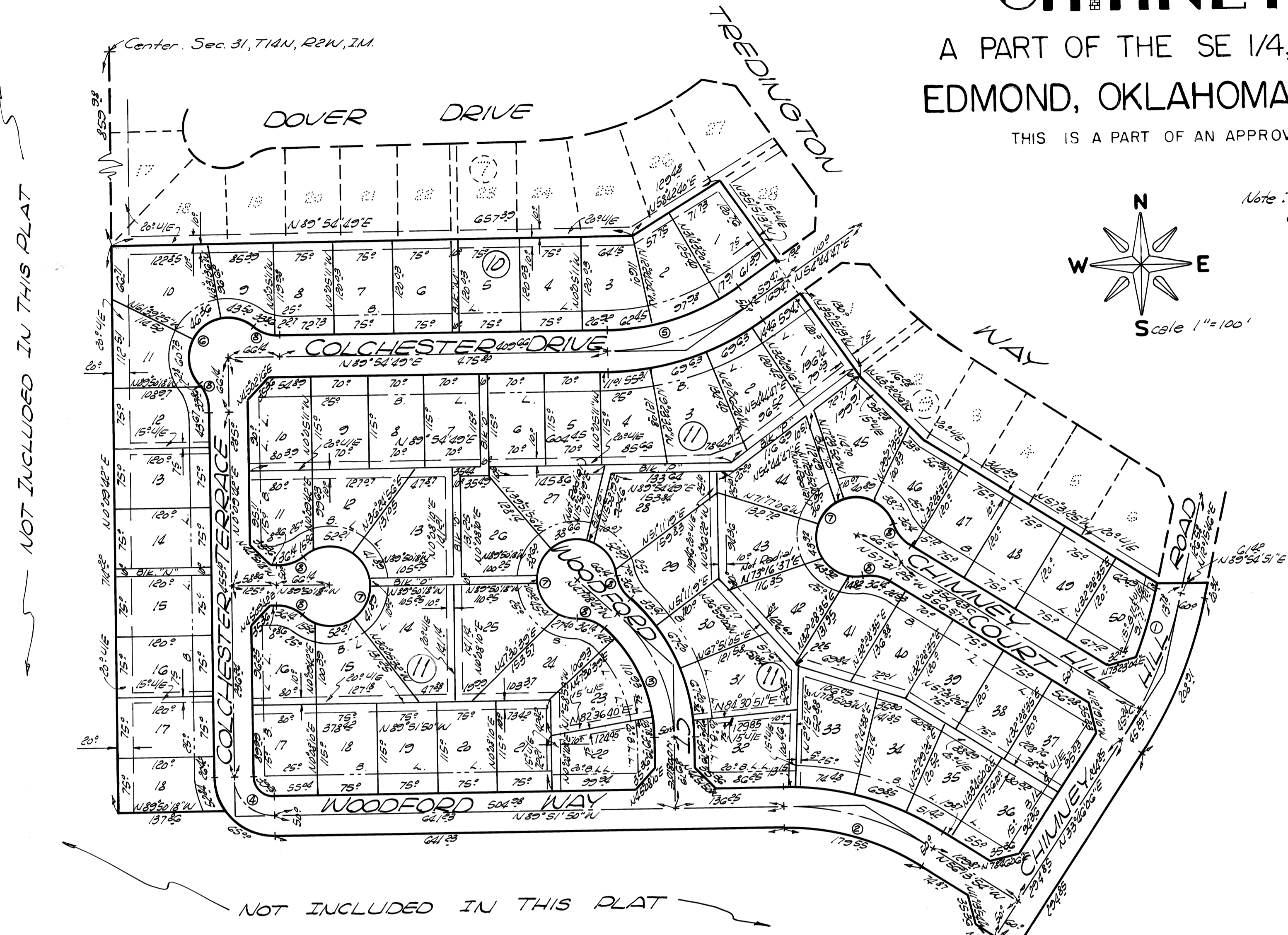

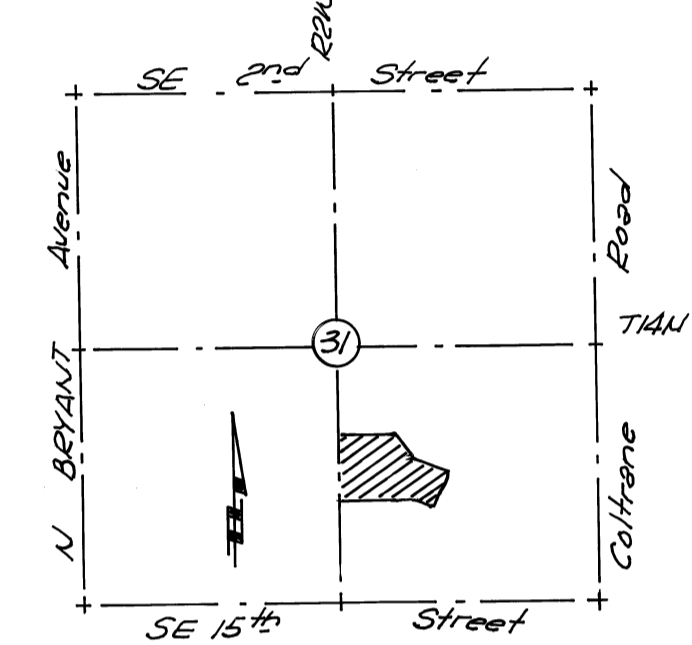
# CHIMNEY HILL IV
