# COLCORD HEIGHTS ADDITION

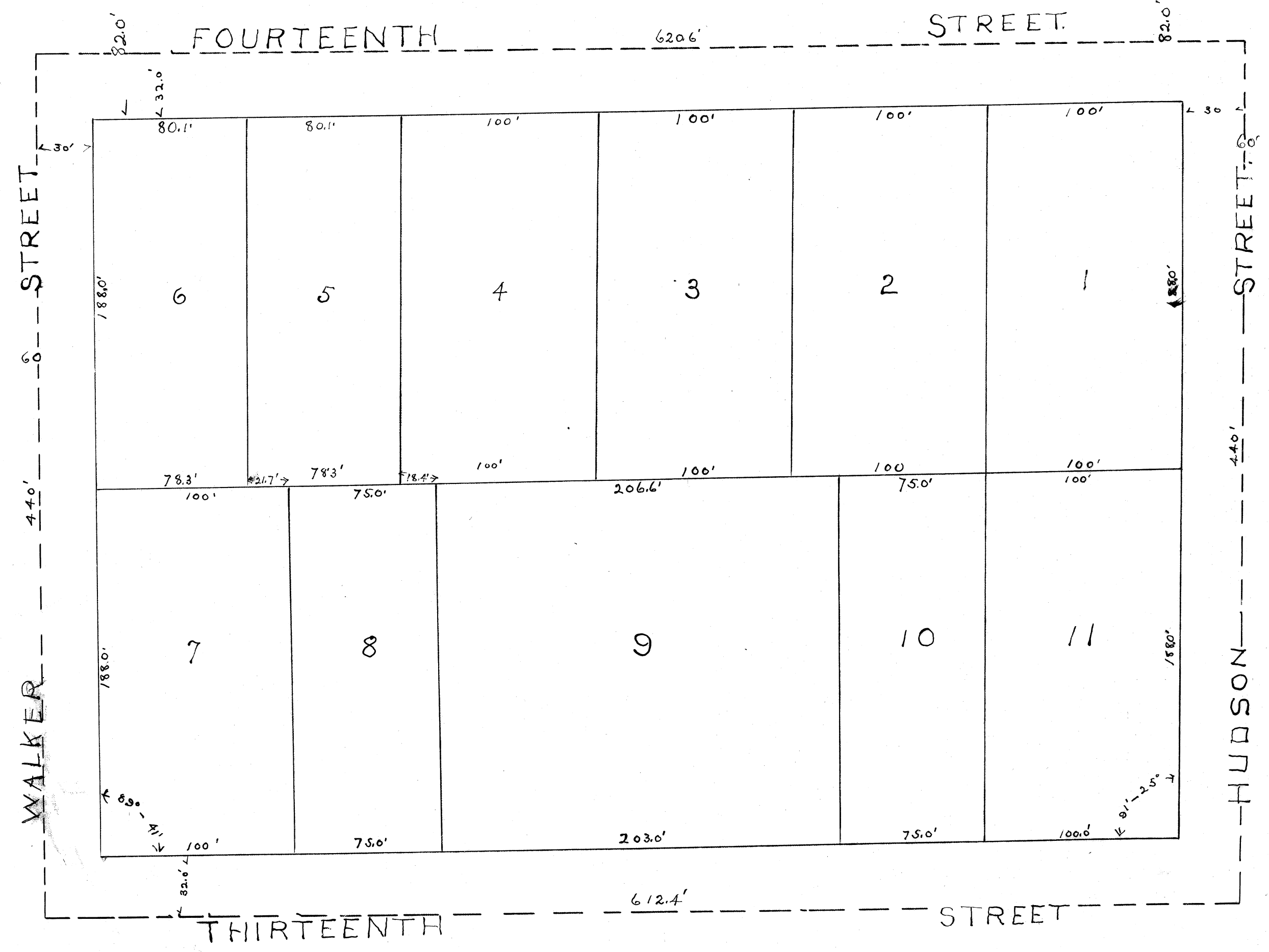

Know all Men by these presents: That We, Charles F. Colcord and Harriet Colcord, husband and wife, owners, have caused to be surveyed and platted into Lots and Streets the following described real estate situate in Oklahoma County, O.T., to-wit: A part of the Southeast Quarter of Section Twenty eight, in Township Twelve North; Range Three West of the Indian Meridian, and more particularly described as follows:— Commencing at a point midway on the West line of said Quarter section; Thence East 612.4 feet Thence North on centerline of Hudson Street 440 feet Thence West 620.6 feet; Thence South 440 feet to the place of beginning.

We hereby adopt the map and plat set out on the attached sheet as a correct representation of the said survey, and name the land so surveyed "Colcord Heights Addition to Oklahoma City, and hereby dedicate the streets to the public use forever.
