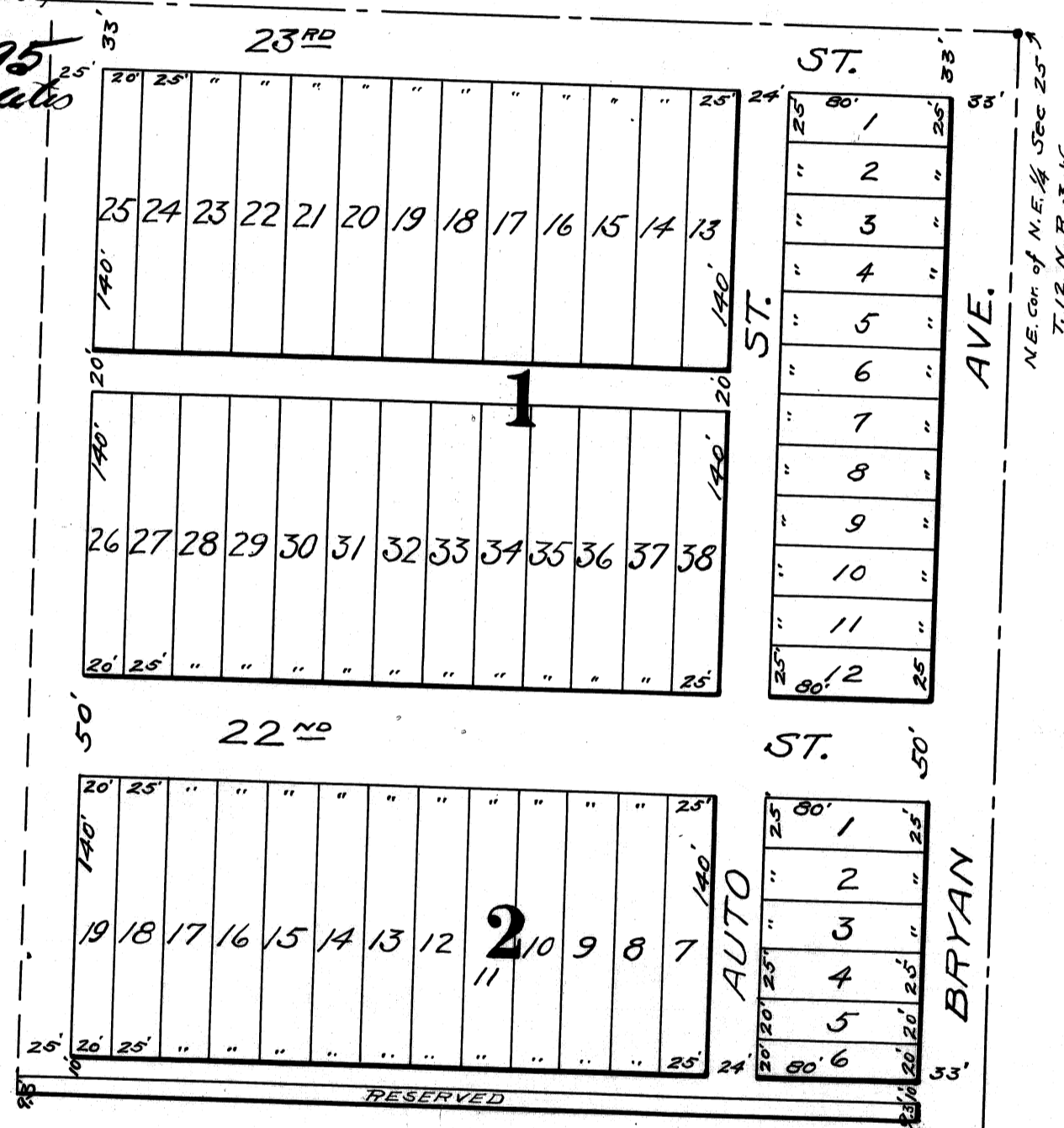

Know All Men By These Presents: That G. H. Tiller and Anna V. Tiller, his wife, being the owners of a part of the North East Quarter of the North East Quarter of Section 25 T. 12 N. R. 3 West of the Indian Meridian, has caused the same to be subdivided into lots, blocks, streets and alleys and that the annexed map or plat is a correct representation of said land as subdivided which we hereby designate and name 'Crestview Addition' to Oklahoma City, Oklahoma, and dedicate the streets and alleys as shown on said map or plat to the public.

RESTRICTIONS:

- No. 1. No lot or block or any portion of either shall ever be sold to any person of African descent, known as Negroes.
- No. 2. No residence shall be built on any lots in this Addition to cost less than One Thousand (\$1000.00) Dollars.
