

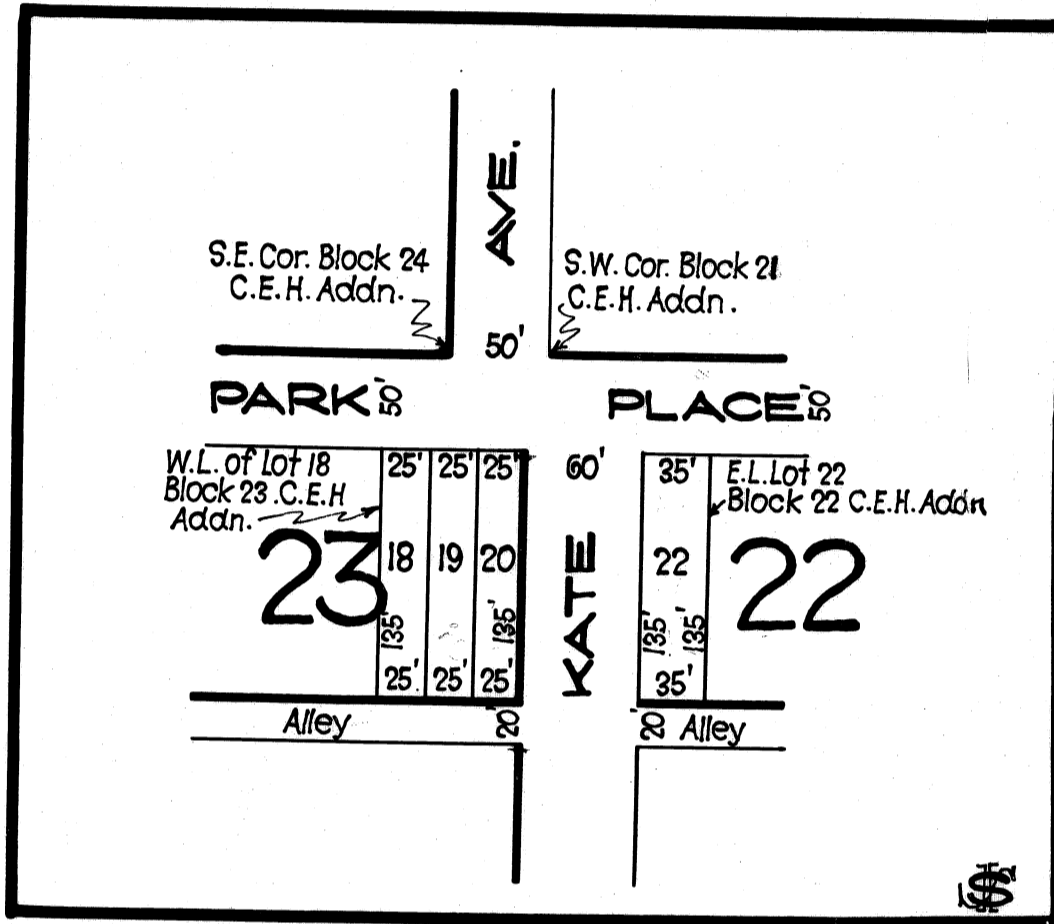

KNOW ALL MEN BY THESE PRESENTS: That we, J. J. Culbertson and Emily Culbertson, his wife, of Paris, Lamar County, State of Texas, are owners of all of Lots Eighteen (18) Block Twenty Three (23) and Lots Twenty Two (22) to Twenty Four (24) inclusive Block Twenty Two (22) of Culbertsons East Highlands Addition and also owners of the adjacent lots thereto and they do hereby vacate the plat of Culbertsons East Highlands Addition as to said lots above described ^(and Kate Street intervening) and have caused same to be resurveyed and replatted and a correct map or plat of same is set out on another sheet and attached hereto and is hereby adopted as such, same being hereby named "Amended plat to parts of Blocks Twenty Two (22) and Twenty Three (23) of Culbertsons East Highlands Addition" to the City of Oklahoma City.

The streets, avenues and alleys as shown upon this plat are dedicated to public use subject to the same restrictions and the property hereby platted is subject to the same restrictions in full as set forth in the original plat of Culbertsons East Highlands Addition to the City of Oklahoma City, filed April 18th, 1907 at 9:45 A.M. and recorded in Book Seven (7) of Plats, Page 28.

The reason for this replatting is to make Kate Street correspond with Kate Street as platted and laid out to the south and for the further reason that Kate Street between Blocks Twenty Two (22) and Twenty Three (23) above mentioned, is and has been always graded and used as is shown by the amended plat herewith filed.
