
## Amended Platof Eckroat Addition to Oklahoma City, O. T.

Amended plat of ECKROAT ADDITION to Oklahoma City, Oklahoma.

KNOW ALL MEN BY THESE PRESENTS:-

That we, John Eckroat and Mary Eckroat, husband and wife, the owners of the following described real estate, situated in the County of Oklahoma, Territory of Oklahoma, to-wit:- That part of the East half of the Northwest quarter of Section Ten (10), in Township Eleven (11) North of Range Three (3) West of the Indian Meridian, bounded and described as follows, to-wit:-Beginning at the northeast corner of said eighty acre tract, thence west one thousand and five (1005) feet to the west line of Ohio Street as shown on the plat of Eckroat Addition to Oklahoma City, Oklahoma; thence south three hundred and ninety-three (393) feet to the south line of Maple Avenue as shown on said plat; thence east on said south line five hundred and forty (540) feet to the west line of College Street as shown on said plat; thence south on said west line six hundred and sixty (660) feet to the north line of Elm Avenue as shown on said plat; thence west on said north line five hundred and forty (540) feet to the west line of Ohio Street as shown on said plat; thence south on said west line three hundred and sixty (360) feet to the north line of Sycamore Avenue as shown on said plat; thence west on said north line to the west line of said eighty acre tract; thence south to the southwest corner of said eighty/acre tract; thence east one hundred and eighty-two (182) and five-tenths (5/10) feet; thence north to the south line of Cottonwood Avenue as shown on said plat; thence east on said south line one hundred and forty (140) feet to the west line of Ohio Street as shown on said plat; thence south on said west line to the south line of said eighty acre tract; thence east on said south line to the southeast corner of said eighty acre tract; thence north to the place of beginning; have caused the same to be sub-divided into lots, blocks, streets, avenues and alleys and hereby designate and name the same "AMENDED PLAT OF ECKROAT ADDITION to Oklahoma City, Oklahoma," and that a correct map or plat of said land is set out on the annexed sheet.

The streets, avenues and alleys as shown on said map are hereby dedicated to the public use forever.
