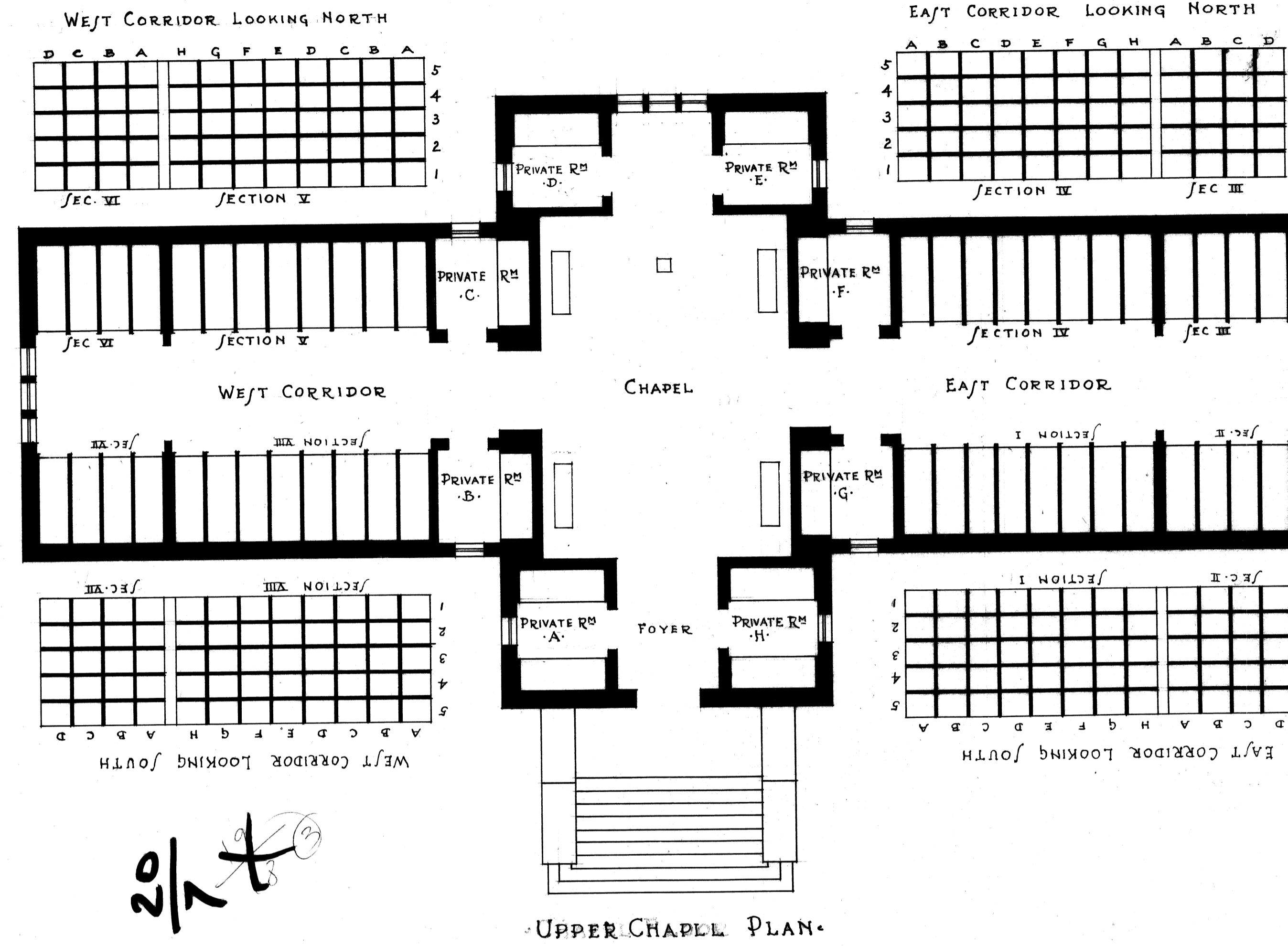

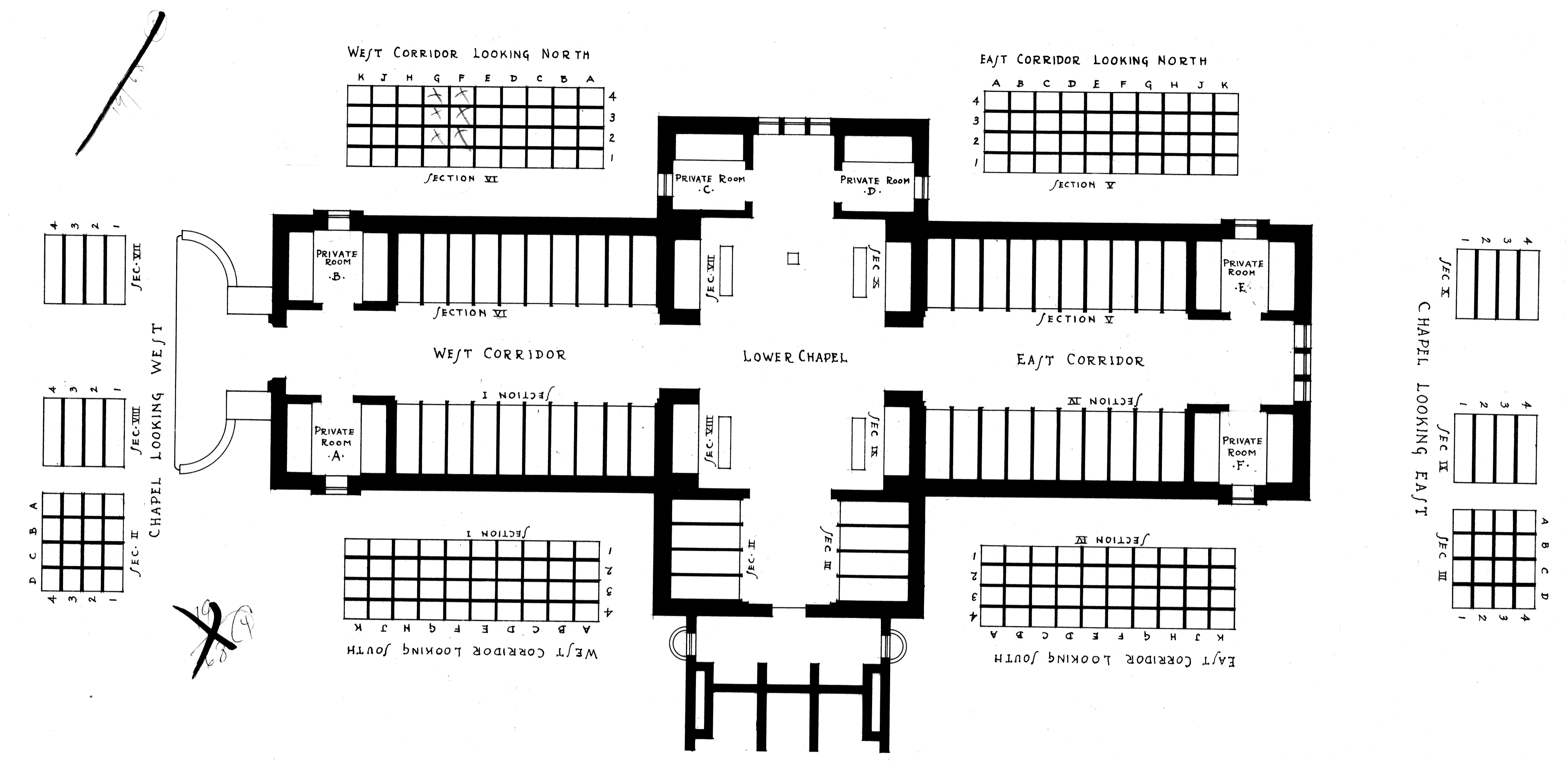

That Fairlawn Cemetery Association, a corporation, organized under the laws of the State of Oklahoma, owner of the following described property, situated in Oklahoma County, State of Oklahoma, to wit, a community mausoleum consisting of two floors, described as upper and lower chapels, containing crypts, de luxe sections, and private rooms, for the burial of the dead, situated in Block Twenty in said Fairlawn Cemetery, hereby adopts the above plat showing the location of said crypts, de luxe sections, and private rooms, under the name of "Fairlawn Mausoleum," and does hereby dedicate said building to the public use, subject to the following restrictions: Said building

all be used only for the purpose of entombing and keeping bodies of persons other than of the negro, Mongolian, any races, and subject, also, to the rules and by-laws Fairlawn Cemetery Association.
