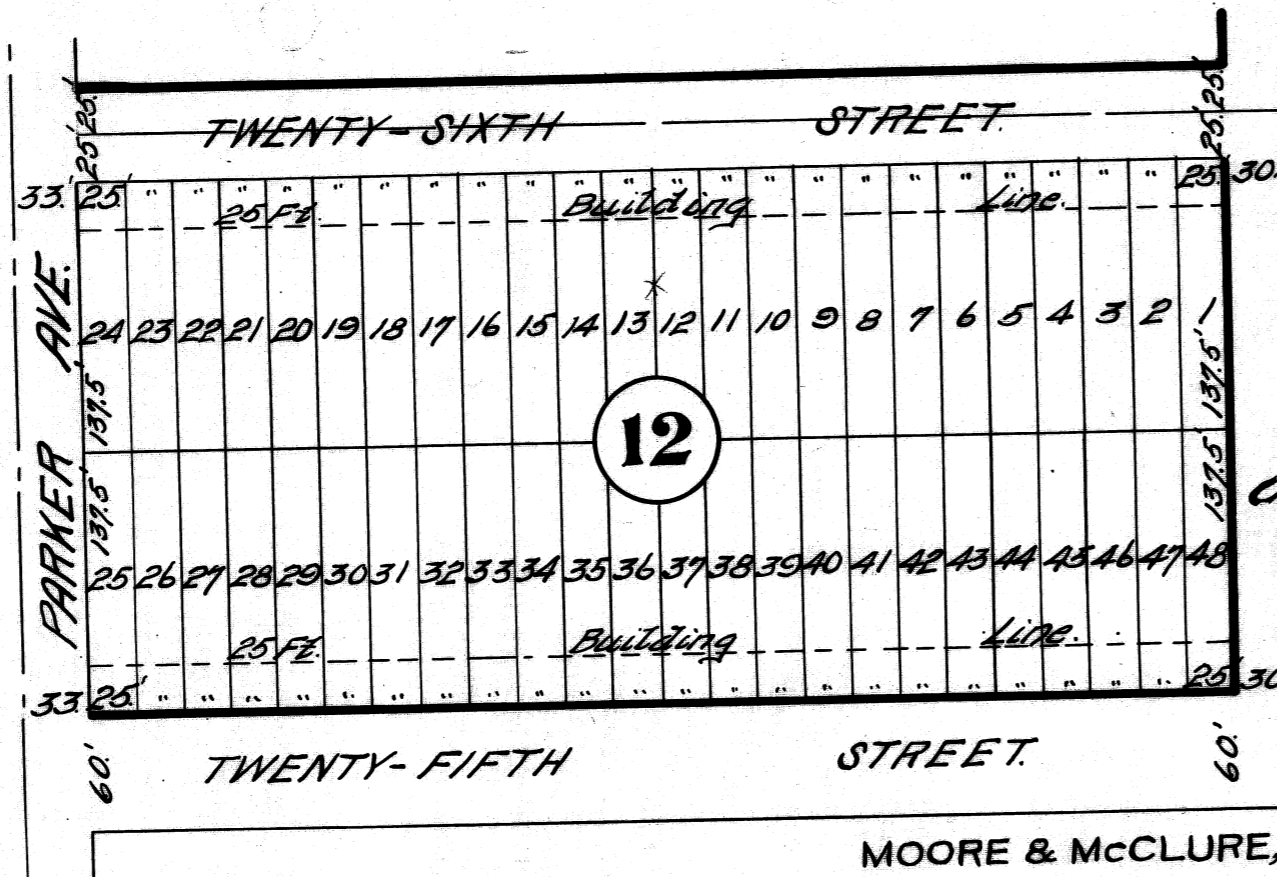


Subdivision of Block 12 FINLEY'S HIGHLAND HOME ADDITION.
