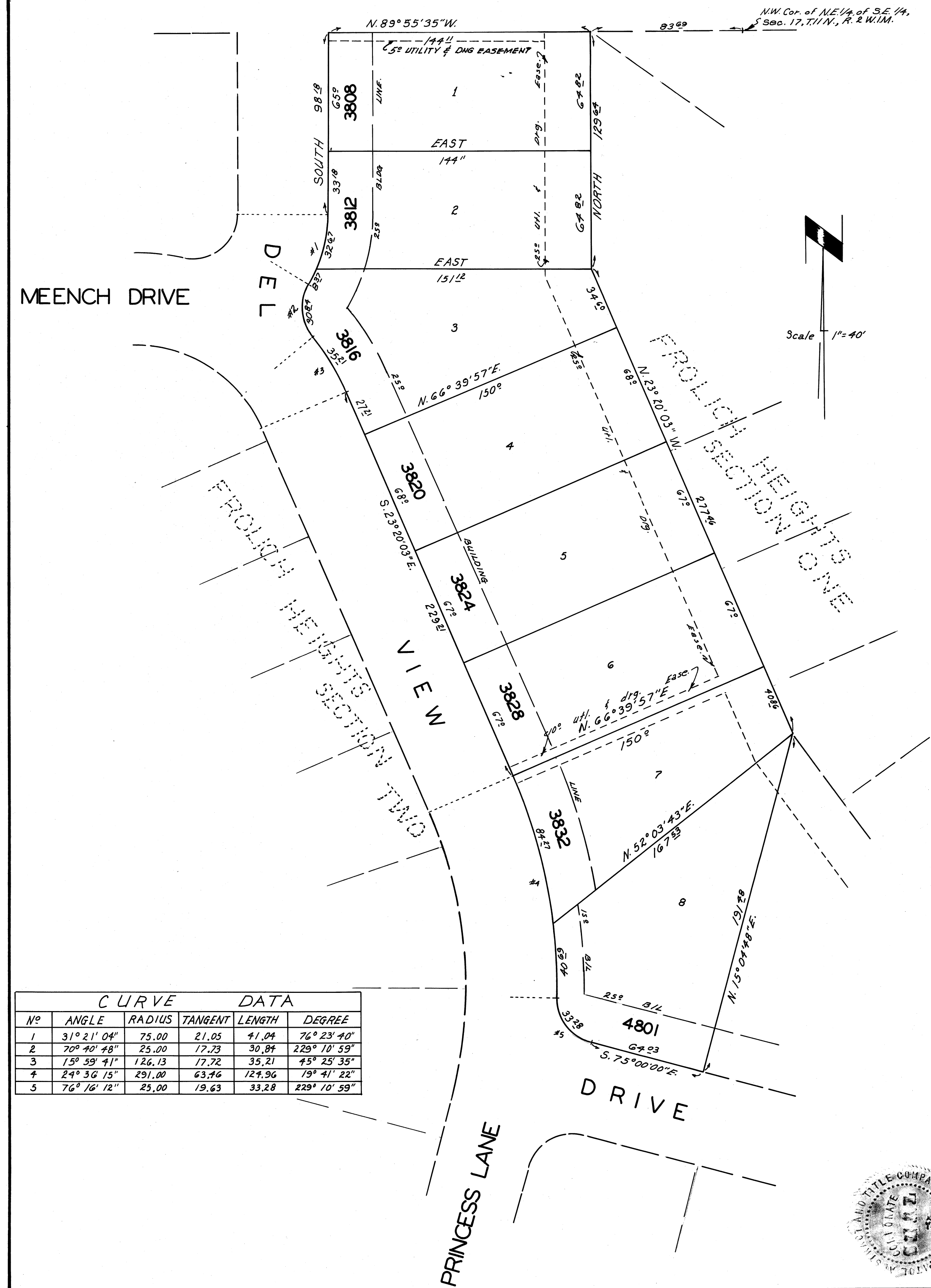


REPLAT OF LOTS 1 THRU 7, BLOCK 3.
