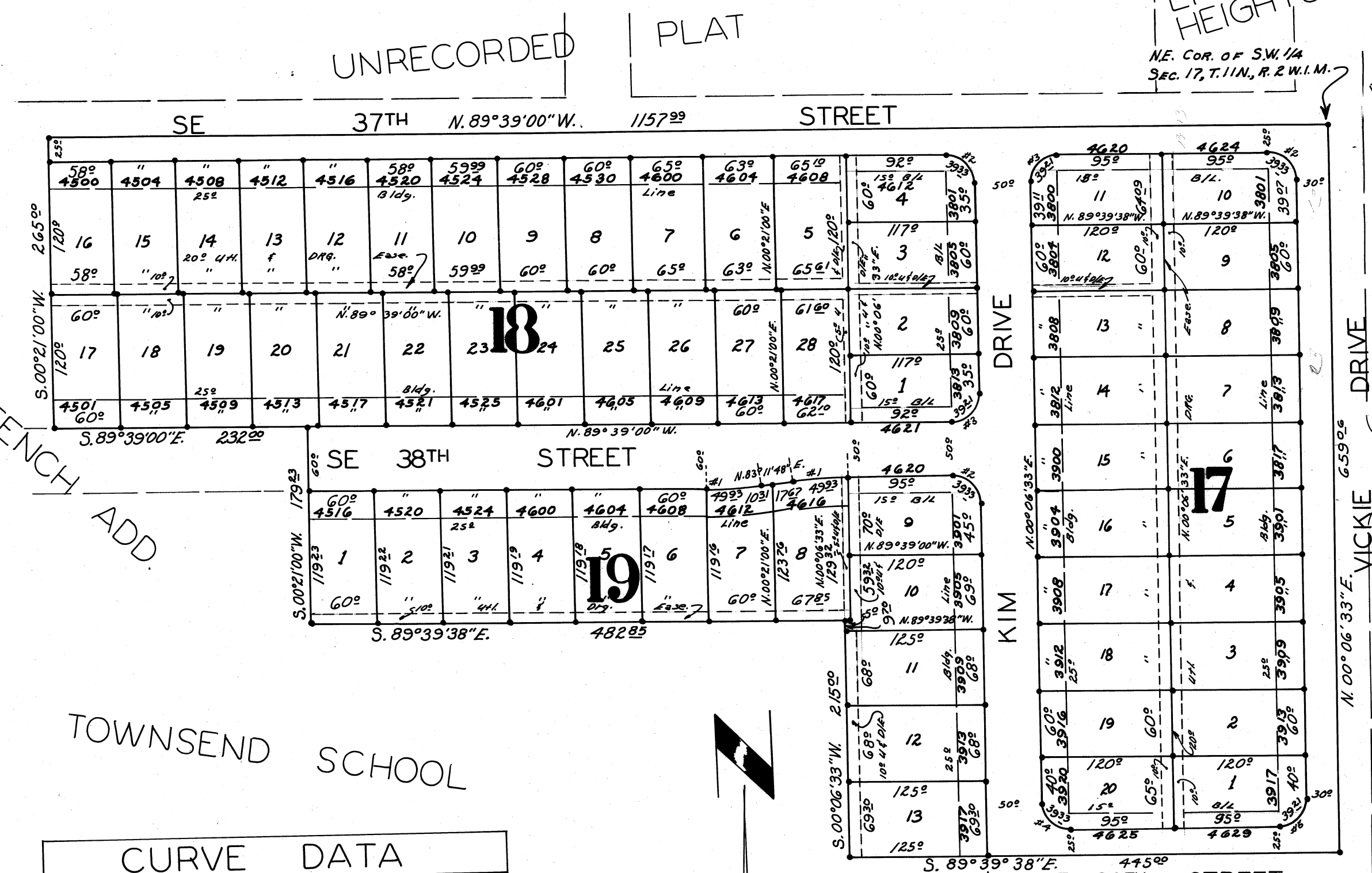
ACCEPTANCE OF DEDICATION BY CITY COUNCIL

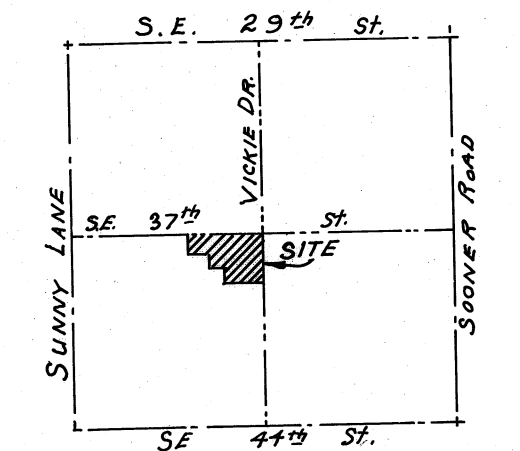
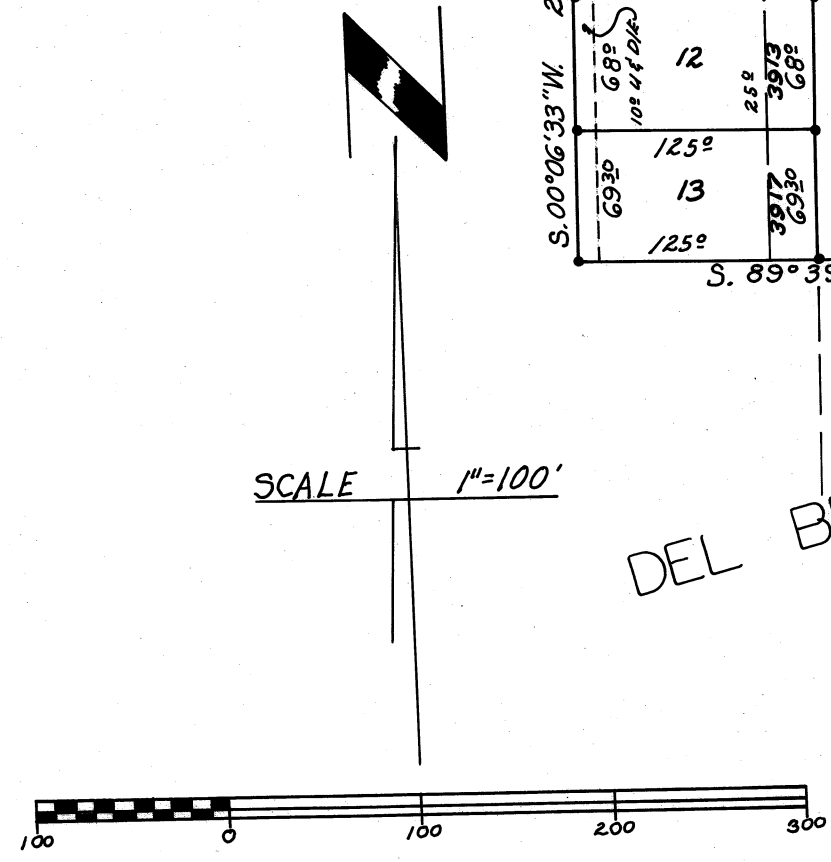
BONDED ABSTRACTOR'S CERTIFICATE
