

Gee's-Addition to Oklahoma City, O.T.

Know all Men by these Presents: That Mr. Bird Gee and Nancy Gee, his wife, owners, have caused to be surveyed and platted the following described tract of land situated in Oklahoma County, O.T. to wit: Commencing at a point 76.3 feet East of the Southwest corner of the Southeast Quarter of Section Thirty-two Township Twelve North; Range Three West of S. M. Thence East 745.6 feet Thence North 3 degrees West 246.4 feet; thence North 28 degrees West 126.4 feet; thence North 39 degrees and 37 minutes West 291.3 feet thence North 55 degrees and 27 minutes West 255.5 feet; thence North 76 degrees and 43 minutes West 241.5 feet. thence South 89 degrees and 11 minutes West 297.6 feet; thence South 74 degrees and 11 minutes West 134.7 feet; thence South 38 degrees and 50 minutes West 106.3 feet thence South 2 degrees and 7 minutes East 208.2 feet; thence South 42 degrees and 5 minutes East 330.6 feet thence South 51 degrees and 54 minutes East 200.9 feet. Thence South 38 degrees East 103 feet to the place of beginning.

We hereby designate and name the same Gee's Addition to Oklahoma City, O.T. We hereby dedicate the Streets and Alleys to public use.

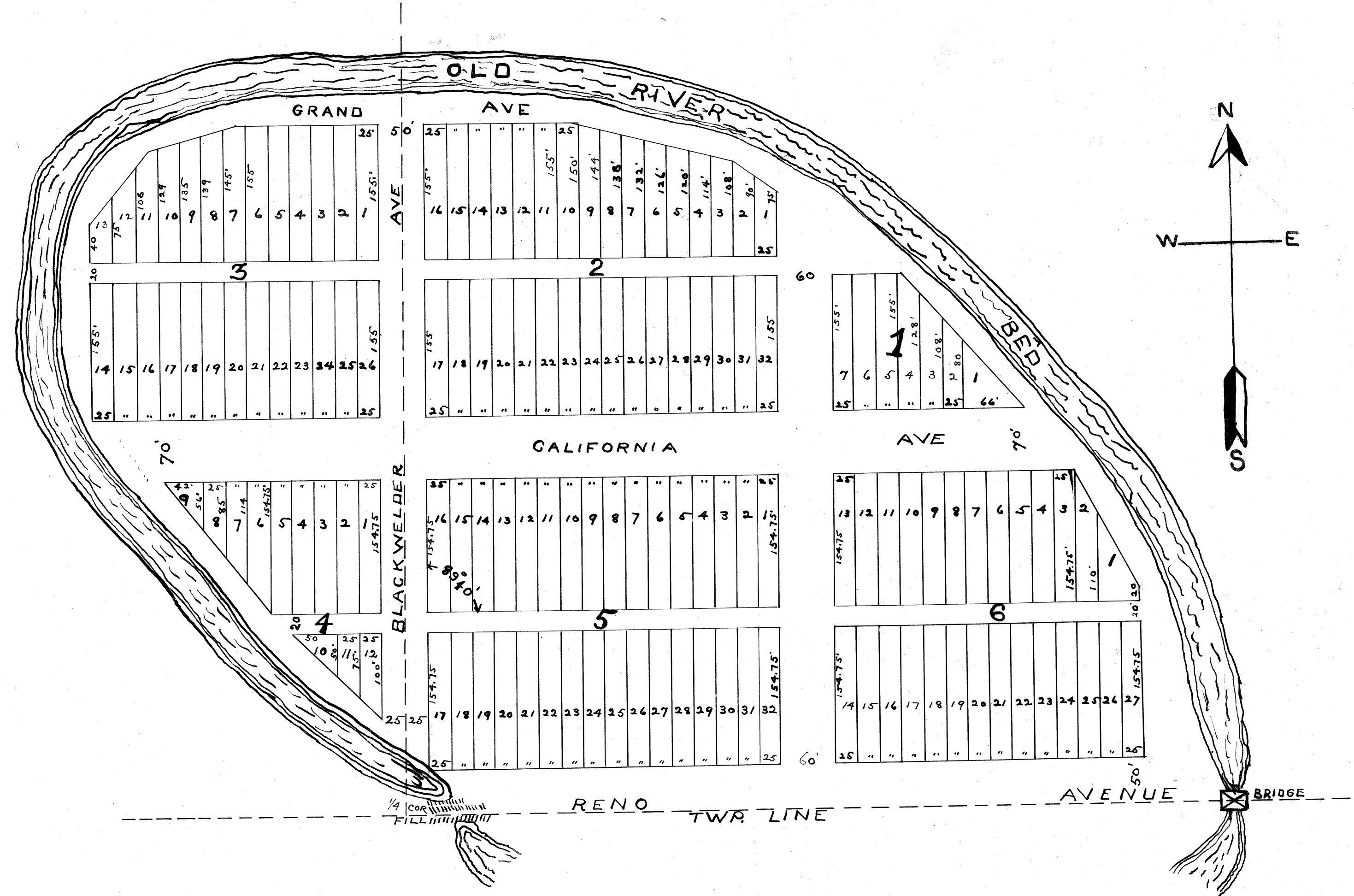
