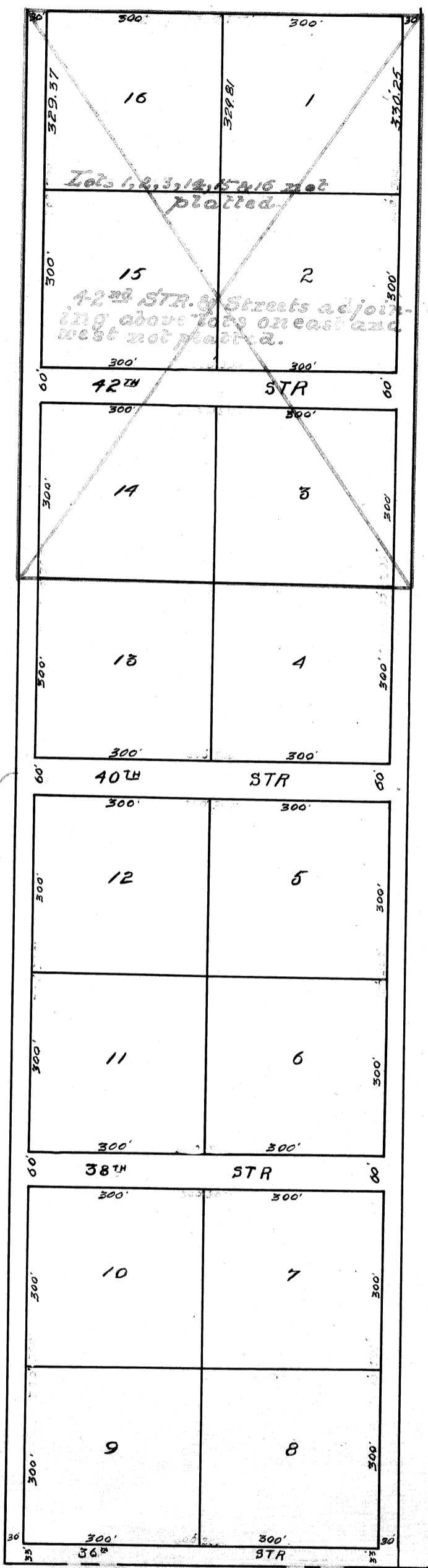

KNOW ALL MEN BY THESE PRESENTS:-

That Kate H. Dunn and Ed L. Dunn, her husband, the owners of that part of the East one-half (1/2) of the West one-half (1/2) of the Southeast quarter (1/4) of Section Eighteen (18), in Township Twelve (12) North of Range Three (3) West of the Indian Meridian, in Oklahoma County, Territory of Oklahoma, described as follows, to-wit:- Beginning at the southeast corner of said tract of land last above described, thence north, on a line parallel with the east line of said section eighteen (18), sixteen hundred fifty-three (1653) feet; thence west, on a line parallel with the south line of said section, six hundred sixty (660) feet; thence south, on a line parallel with the east line of said section, sixteen hundred fifty-three (1653) feet; to the south line of said section; thence east, along the south line of said section, six hundred sixty (660) feet, to the place of beginning, have caused the same to be surveyed and platted into lots and streets as shown on the annexed map or plat.
