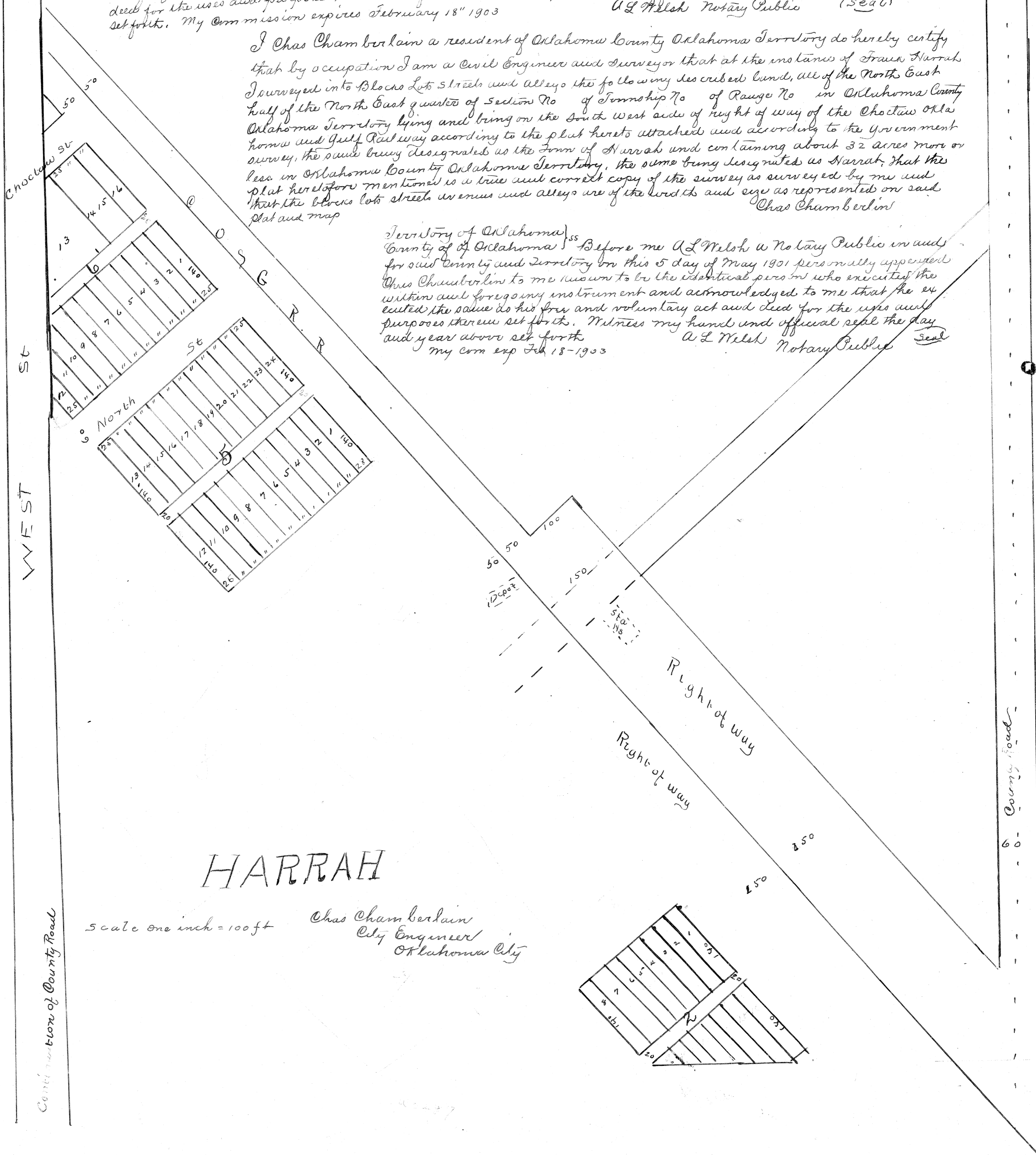

This instrument witnesses that Frank Harrah of Oklahoma City Oklahoma Territory the owner of the land hereinafter described has caused the same to be surveyed into blocks lots streets avenues and alleys for townsite purposes and I hereby designate and name the same as Harrah. That I have caused to be made a correct plat of said land as surveyed that the land surveyed and platted aforesaid is described and bounded as follows to wit: being all of the East half of the North East quarter of Section No. 13 of Township No. 10 N. Range No. 10 E. Oklahoma County Oklahoma Territory lying on the South West side of the South West line of right of way of the C. O. & R. R. according to the plat hereto attached and according to the Government survey the same being designated as the Town of Harrah and containing about 32 acres more or less.
